I. SUMMARY:

This legislation re-creates the Retiree Health Insurance Subsidy Trust Fund, Flair #72-2-583, without modification, effective upon becoming a law. The Retiree Health Insurance Subsidy Trust Fund is administered by the Department of Management Services. This fund was last reviewed by the Legislature in Chapter 97-140, Laws of Florida.
