# I. SUMMARY:

This legislation re-creates the Law Enforcement Radio System Trust Fund, Flair #72-2-432, without modification, effective November 4, 2004. The Law Enforcement Radio System Trust Fund is administered by the Department of Management Services. This fund was last re-created effective November 4, 2000, by Chapter 97-138, Laws of Florida.

### 1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 282.1095, F.S., creates the trust fund, provides purpose and revenue sources.

The Law Enforcement Radio System Trust Fund provides funding for the acquisition and operation of a statewide radio communication system.

## 3. MAJOR SOURCES OF REVENUE FOR THE FUND:

Two sources of revenues for the fund are surcharges on boat and vehicle registrations and interest earnings.

This bill re-creates the trust fund without modification.
