The Department of State shall give each proposed constitutional amendment a designating number for convenient reference. This number designation shall appear on the ballot. Designating numbers shall be assigned in the order of filing or certification and in accordance with rules adopted by the Department of State of the amendments. The Department of State shall furnish the designating number, the ballot title, and the substance of each amendment to the supervisor of elections of each county in which such amendment is to be voted on.

The advance absentee ballot for the second primary shall be the same as the first primary absentee ballot as to the names of candidates, except that for any offices where there are only two candidates, those offices and all political party executive committee offices shall be omitted. Except as

provided in s. 99.063(4), the advance absentee ballot for the 2 general election shall be as specified in s. 101.151, except 3 that in the case of candidates of political parties where 4 nominations were not made in the first primary, the names of 5 the candidates placing first and second in the first primary election shall be printed on the advance absentee ballot. The 6 7 advance absentee ballot or advance absentee ballot information booklet shall be of a different color for each election and 8 also a different color from the absentee ballots for the first 9 primary, second primary, and general election. The supervisor 10 shall mail an advance absentee ballot for the second primary 11 12 and general election to each qualified absent elector for whom a request is received until the absentee ballots are printed. 13 14 The supervisor shall enclose with the advance second primary absentee ballot and advance general election absentee ballot 15 an explanation stating that the absentee ballot for the 16 17 election will be mailed as soon as it is printed; and, if both the advance absentee ballot and the absentee ballot for the 18 19 election are returned in time to be counted, only the absentee 20 ballot will be counted. (11) Conduct preliminary investigations into any irregularities or fraud involving voter registration or voting and report its findings to the state attorney for the judicial circuit in which the alleged violation occurred for prosecution, where warranted. The Department of State may prescribe by rule requirements for filing a complaint of voter fraud and for investigating any such complaint.
