2	An act relating to postsecondary education;
3	providing legislative intent; redesignating St.
4	Petersburg Junior College as St. Petersburg
5	College; requiring accreditation; providing
6	mission; providing for students and fees;
7	providing conditional authority to offer
8	baccalaureate degree level programs;
9	authorizing certain baccalaureate degree
10	programs and a process for increasing their
11	number; establishing a board of trustees and a
12	coordinating board; providing for employment;
13	providing for the acquisition of land,
14	buildings, and equipment; authorizing the power
15	of eminent domain; providing intent for state
16	funding; requiring a cost study; providing an
17	effective date.

19	Be It Enacted by the Legislature of the State of Florida:
20	
21	Section 1. Legislative intentThe Legislature
22	intends to create an innovative means to increase access to
23	baccalaureate degree level education in populous counties that
24	are underserved by public baccalaureate degree granting
25	institutions. This education is intended to address the
26	state's workforce needs, especially the need for teachers,
27	nurses, and business managers in agencies and firms that
28	require expertise in technology.
29	Section 2. St. Petersburg College; missionSt.
30	Petersburg Junior College is redesignated as St. Petersburg
31	College. The college shall immediately seek accreditation from

the Southern Association of Colleges and Schools as a 1 2 baccalaureate degree granting college. (1) The primary mission of St. Petersburg College is 3 4 to provide high-quality undergraduate education at an 5 affordable price for students and the state. The purpose is to б promote economic development by preparing people for 7 occupations that require a bachelor's degree and are in demand by existing or emerging public and private employers in this 8 9 state. 10 (2) St. Petersburg College shall maintain the mission and policies of a Florida community college, including the 11 12 open-door admissions policy and the authority to offer all 13 programs consistent with a public community college's 14 authority. 15 (3) St. Petersburg College shall maintain the 16 distinction between the college and its university center. St. Petersburg College is limited to community college programs 17 and to selected baccalaureate degree level programs that meet 18 19 community needs and are authorized as provided by this act. 20 The University Center may make available more diverse program offerings, but those programs are offered by a participating 21 22 college or university and are not to be classified or funded as programs of St. Petersburg College. 23 24 (4) The academic policies of the upper-division program at St. Petersburg College must be in accordance with 25 26 policies of the State University System. 27 (5) Sections 240.293 and 240.2945, Florida Statutes, 28 apply to St. Petersburg College. 29 Section 3. St. Petersburg College; students.--(1) St. Petersburg College shall maintain separate 30 records for students who are enrolled in courses classified in 31 2

the lower division and the upper division of a baccalaureate 1 2 program according to the common course numbering system. A student shall be reported as a community college student for 3 enrollment in a lower-division course and as a baccalaureate 4 degree program student for enrollment in an upper-division 5 б course. 7 (2) The Board of Trustees of St. Petersburg College 8 shall establish the level of matriculation, tuition, and other 9 authorized student fees. 10 (a) For each credit hour of enrollment in a certificate level course or lower-division level college 11 12 credit course, matriculation and tuition fees must be within 13 the range authorized in law and rule for a community college 14 student at that level. 15 (b) For each credit hour of enrollment in an upper-division level course, matriculation and tuition fees 16 must be in an amount established by the Board of Trustees of 17 St. Petersburg College. However, fees for upper-division 18 19 students must reflect the fact that the college does not incur 20 the costs of major research programs. Therefore, the board of trustees shall establish fees for upper-division students 21 22 within a range that is lower than the fees established for 23 students at a public university but higher than the fees for 24 community college students. (c) Other mandatory fees and local fees must be at the 25 26 same level for all lower-division students. For upper-division 27 students, other mandatory fees and local fees must be at a 28 level less than fees established for University of South Florida students, regardless of program enrollment or level. 29 However, students in workforce development education courses 30 maintain the authorized fee exemptions described in s. 31

239.117, Florida Statutes, and may be exempt from local fees 1 imposed by the board of trustees, at the board's discretion. 2 3 Section 4. St. Petersburg College; degrees .--4 (1) In addition to the certificates, diplomas, and degrees authorized in s. 240.301, Florida Statutes, St. 5 6 Petersburg College may offer selected baccalaureate degrees. 7 Initially, the college may offer programs that lead to a 8 baccalaureate degree in the following fields: 9 (a) Bachelor of science in nursing. This program must be designed to articulate with the associate in science degree 10 in nursing. St. Petersburg College shall continue to offer the 11 12 associate in science degree in nursing. 13 (b) Bachelor of arts and bachelor of science in 14 elementary education. 15 (c) Bachelor of arts and bachelor of science in 16 special education. (d) Bachelor of arts and bachelor of science in 17 18 secondary education. 19 (e) Bachelor of applied science in fields selected by 20 the Board of Trustees of St. Petersburg College. The board of trustees shall base the selection on an analysis of workforce 21 22 needs and opportunities in the following counties: Pinellas, Pasco, Hernando, and other counties approved by the Department 23 of Education. For each program selected, St. Petersburg 24 25 College must offer a related associate in science or associate 26 in applied science degree program, and the baccalaureate degree level program must be designed to articulate fully with 27 28 at least one associate in science degree program. The college 29 is encouraged to develop articulation agreements for enrollment of graduates of related associate in applied 30 science degree programs. 31

(2) St. Petersburg College may offer courses that 1 2 enable teachers to qualify for certification and 3 recertification as required by law or rule. 4 (3) St. Petersburg College may offer programs to 5 provide opportunities for a person who holds a baccalaureate degree, but is not certified to teach, to obtain any 6 7 additional courses required for teacher certification. 8 (4) Masters degree level programs and doctoral 9 programs may be provided by agreement with a college or university participating in the University Center of St. 10 11 Petersburg College. 12 (5) For those students living outside the St. 13 Petersburg College service area, St. Petersburg College shall 14 recruit for the upper division only those students who have 15 earned an associate degree. In recruiting upper-division students in Pasco and Hernando Counties, St. Petersburg 16 College shall work cooperatively with Pasco-Hernando Community 17 College and shall seek to offer courses and programs at 18 19 Pasco-Hernando Community College when feasible. 20 Section 5. St. Petersburg College; boards.--(1) The Board of Trustees of St. Petersburg Junior 21 College is renamed the Board of Trustees of St. Petersburg 22 23 College and serves as its governing board. The Governor shall appoint members as provided in s. 240.313, Florida Statutes, 24 and the board of trustees has the duties and authorities 25 26 granted in ss. 240.315 and 240.319, Florida Statutes, and by 27 rules of the State Board of Education. 28 (2) The Board of Trustees of St. Petersburg College 29 may authorize direct-support organizations as authorized in ss. 240.299 and 240.331, Florida Statutes. 30 31

1	(3) The Board of Trustees of St. Petersburg College
2	may continue to award degrees, diplomas, and certificates as
3	authorized for St. Petersburg Junior College, and in the name
4	of St. Petersburg Junior College, until St. Petersburg College
5	receives its accreditation.
б	(4) A coordinating board shall assist the board of
7	trustees in its deliberations concerning issues that affect
8	the upper division of St. Petersburg College. The coordinating
9	board consists of the President of the University of South
10	Florida, the President of St. Petersburg College, the
11	President of Pasco-Hernando Community College, and the chairs
12	of the boards of trustees of those institutions.
13	(5) Beginning 4 years after St. Petersburg College
14	receives accreditation to offer baccalaureate degrees, the
15	board of trustees of the college may determine additional
16	programs to be offered, with the approval of the coordinating
17	board. The determination must consider community needs and
18	economic opportunities.
19	(6) The coordinating board shall meet at the request
20	of the President of the University of South Florida or the
21	President of St. Petersburg College.
22	(7) If the coordinating board cannot decide an issue
23	of importance to the programs designed for upper-division
24	students, the chief educational officer of this state shall
25	resolve the issue.
26	Section 6. St. Petersburg College; employees
27	(1) Employment at St. Petersburg College is governed
28	by the same laws that govern community colleges, except that
29	upper-division faculty are eligible for continuing contracts
30	upon the completion of the fifth year of teaching.

1	(2) Employee records for all personnel shall be
2	maintained as required by s. 240.337, Florida Statutes.
3	Section 7. St. Petersburg College; facilitiesSt.
4	Petersburg College may request funding from the Public
5	Education Capital Outlay and Debt Service Trust Fund as a
6	community college and as a university. The municipalities of
7	Pinellas County, the Board of County Commissioners of Pinellas
8	County, and all other governmental entities are authorized to
9	cooperate with the Board of Trustees of St. Petersburg College
10	in establishing this institution. The acquisition and donation
11	of lands, buildings, and equipment for the use of St.
12	Petersburg College are authorized as a public purpose. The
13	Board of County Commissioners of Pinellas County and all
14	municipalities of Pinellas County may exercise the power of
15	eminent domain to acquire lands, buildings, and equipment for
16	the use of St. Petersburg College, regardless of whether such
17	lands, buildings, and equipment are located in a community
18	redevelopment area.
19	Section 8. St. Petersburg College; state funding
20	(1) The Legislature intends to fund St. Petersburg
21	College as a community college for its workforce development
22	education programs and for its lower-division level college
23	credit courses and programs.
24	(2) The Legislature intends to fund St. Petersburg
25	College as a baccalaureate degree level institution for its
26	upper-division level courses and programs.
27	(3) During the 2001-2002 fiscal year, St. Petersburg
28	College shall estimate the appropriate level of funding for
29	these programs. By March 1, 2002, the college shall complete a
30	cost study and shall submit to the Legislature a proposal for
31	cost accounting and legislative budget requests designed to

1	acknowledge its unique classification. The cost study must
2	indicate actual costs projected for the first 4 years of
3	operation as a baccalaureate degree level institution, with
4	the first students expected to enroll in the upper division in
5	the fall semester of 2002.
б	Section 9. This act shall take effect July 1, 2001.
