

(4) The Legislature further recognizes the need for 8 enhancing the ability of rural landowners to obtain economic 9 value from their property, protecting rural character, 10 controlling urban sprawl, and providing necessary open space 11 12 for agriculture and the natural environment, and the importance of maintaining and protecting Florida's rural 13 economy through innovative planning and development strategies 14 15 in rural areas and the use of incentives that reward landowners for good stewardship of land and natural resources. 16 17 (5) The purpose of this act is to bring under public 18 protection lands that serve to limit subdivision and conversion of agricultural and natural areas that provide 19 economic, open space, water, and wildlife benefits by 20 acquiring land or related interests in land such as perpetual, 21 less-than-fee acquisitions, agricultural protection 22 agreements, and resource conservation agreements and 23 24 innovative planning and development strategies in rural areas 25 Section 4. (a) 15 704.06. 16 (b) Purchase rural-lands-protection easements pursuant 17 to this act. 18 (c) Fund resource conservation agreements pursuant to 19 this act. 20 (d) Fund agricultural protection agreements pursuant 21 to this act. 22 23 No funds may be expended to implement this subsection prior to 24 July 1, 2002. 25 (3) Rural-lands-protection easements shall be a perpetual right or interest in agricultural land which is 26 27 appropriate to retain such land in predominantly its current state and to prevent the subdivision and conversion of such 28 29 land into other uses. This right or interest in property shall 30 prohibit only the following: Construction or placing of buildings, roads, 31 (a) 3

They will be for a term of not less than 5 20 years and not more than 10 years. Property owners will become 21 22 eligible to enter into a resource conservation agreement only upon entering into a conservation easement or rural lands 23 24 protection easement. 25 Agricultural protection agreements shall be for (5) terms of 30 years and will provide payments to landowners 26 27 having significant natural areas on their land. Public access and public recreational opportunities may be negotiated at the 28 29 request of the landowner. (a) For the length of the agreement, the landowner 30 31 shall agree to prohibit: 4

Construction or placing of buildings, roads, 1 1. 2 billboards or other advertising, utilities, or structures, 3 except those structures and unpaved roads necessary for the 4 agricultural operations on the land or structures necessary for other activities allowed under the easement, and except 5 6 for linear facilities described in s. 704.06(11); 7 2. Subdivision of the property; 8 3. Dumping or placing of trash, waste, or offensive 9 materials; and 10 4. Activities that affect the natural hydrology of the land, or that detrimentally affect water conservation, erosion 11 12 control, soil conservation, or fish or wildlife habitat. 13 (b) As part of the agricultural protection agreement, the parties shall agree that the state shall have a right to 14 15 buy a conservation easement or rural land protection easement at the end of the 30-year term or prior to the landowner 16 17 transferring or selling the property, whichever occurs later. 18 If the landowner tenders the easement for the purchase and the state does not timely exercise its right to buy the easement, 19 the landowner shall be released from the agricultural 20 agreement. The purchase price of the easement shall be 21 established in the agreement and shall be based on the value 22 of the easement at the time the agreement is entered into, 23 24 plus a reasonable escalator multiplied by the number of full 25 calendar years following the date of the commencement of the agreement. The landowner may transfer or sell the property 26 27 before the expiration of the 30-year term, but only if the property is sold subject to the agreement and the buyer 28 29 becomes the successor in interest to the agricultural protection agreement. Upon mutual consent of the parties, a 30 31 landowner may enter into a perpetual easement at any time 5

during the term of an agricultural protection agreement. 1 2 (6) Payment for conservation easements and rural land 3 protection easements shall be a lump-sum payment at the time 4 the easement is entered into. 5 (7) Landowners entering into an agricultural 6 protection agreement may receive up to 50 percent of the 7 purchase price at the time the agreement is entered into and remaining payments on the balance shall be equal annual 8 payments over the term of the agreement. 9 10 (8) Payments for the resource conservation agreements 11 shall be equal annual payments over the term of the agreement. 12 Easements purchased pursuant to this act may not (9) 13 prevent landowners from transferring the remaining fee value 14 with the easement. 15 (10)The department, in consultation with the Department of Environmental Protection, the water management 16 17 districts, the Department of Community Affairs, and the Florida Fish and Wildlife Conservation Commission, shall adopt 18 rules that establish an application process, a process and 19 criteria for setting priorities for use of funds consistent 20 with the purposes specified in s. 570.71(1) and giving 21 preference to ranch and timber lands managed using sustainable 22 practices, an appraisal process, and a process for title 23 review and compliance and approval of the rules by the Board 24 25 of Trustees of the Internal Improvement Trust Fund.
