12 (b) Certificates evidencing coverage under the policy  
13 are issued to residents of this state and contain in  
14 contrasting color and not less than 10-point type the  
15 following statement: "The benefits of the policy providing  
16 your coverage are governed primarily by the law of a state

18 (c) Applications for certificates of coverage offered  
19 to residents of this state contain in contrasting color and  
20 not less than 12-point type the following statement on the  
21 same page as the applicant signature: "This policy is  
22 primarily governed by the laws of {insert state where the  
23 master policy is filed.} As a result, all of the rating laws  
24 applicable to policies filed in Florida do not apply to the  
25 coverage, which may result in increases in your premium at  
26 renewal that would not be permissible under a Florida-approved  
27 policy. Any purchase of individual health insurance should be  
28 considered carefully, as future medical conditions may make it  
29 impossible to qualify for another individual health policy.
