Section 409.9205, Florida Statutes, is 15 amended to read: 16 409.9205 Medicaid Fraud Control Unit; law enforcement 17 officers.--18 (1) Except as provided in s. 110.205, all positions in 19 the Medicaid Fraud Control Unit of the Department of Legal 20 Affairs are transferred to the Career Service System. (2) All investigators employed by the Medicaid Fraud 21 22 Control Unit who have been certified under s. 943.1395 are law 23 enforcement officers of the state. Such investigators have the authority to conduct criminal investigations, bear arms, make 24 25 arrests, and apply for, serve, and execute search warrants, 26 arrest warrants, capias, and other process throughout the 27 state pertaining to Medicaid fraud as described in this 28 chapter. The Attorney General shall provide reasonable notice 29 of criminal investigations conducted by the Medicaid Fraud Control Unit to, and coordinate those investigations with, the 30 31 sheriffs of the respective counties.
