I. SUMMARY:

This bill amends s. 372.57(4)(b), F. S., to remove a state subsidy for leasing private property as a wildlife management area for public use in the Fish and Wildlife Conservation Commission (FWCC).

The changes reflect budget reductions contained within the House Appropriations bill and reduced spending of \$379,568 in General Revenue in FWCC.

B. PRESENT SITUATION:

In an effort to slow the loss of privately-owned lands from the FWCC's Wildlife Management Area (WMA) system, the 1998 Florida Legislature adopted revisions to s. 372.57, F.S., which created a new paradigm for inclusion of lands in the WMA system. That new paradigm, termed User Pay, authorized the Commission to charge a special recreational use permit fee for hunting, fishing, or other outdoor recreational use of lands leased from private non-governmental landowners under a program to be established under the umbrella of the existing Type I WMA program. Proceeds from the sale of such permits, less a \$25 administration fee, are subsequently directed to the landowner as compensation for making his land available for this public purpose. The legislation further required that the FWCC make an additional supplementary payment to owners of lands included in the User Pay program which had been previously included in the WMA program under the preexisting Landowner Payment program. The statute specifically provides that private property leased by the Commission under the Landowner Payment program and subsequently converted to the User Pay program is eligible for a continuing supplementary payment equal to the FWCC's lease payment in the final year of participation under the Landowner Payment program. The statute requires the FWCC to make such payment to landowners in addition to the fees collected from the sale of the recreational use permit as described above.

C. EFFECT OF PROPOSED CHANGES:

The bill amends s. 372.57(4)(b)2, F. S., to eliminate the provision requiring that the prior year's landowner payment amount be used to defray cost of individual user permits on areas that convert to a recreational user permit area (user pay area). The effect is to eliminate a state subsidy for leasing property for public use which will shift the full cost of the lease to area users. It also provides an effective date of July 1, 2001.
