# I. SUMMARY:

This legislation re-creates the Supervision Trust Fund, Flair #72-2-696, without modification, effective November 4, 2004. The Supervision Trust Fund is administered by the Department of Management Services. This fund was last re-created effective November 4, 2000, by Chapter 97-147, Laws of Florida.

## II. SUBSTANTIVE ANALYSIS:

#### A. PRESENT SITUATION:

## 1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 255.503, F.S., provides authority to create the trust fund, provides purpose and revenue sources.

# 2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The Supervision Trust Fund provides funding for the operation and maintenance of the Florida Facilities Pool office space, including parking facilities, grounds, and security as provided by Capitol Police within the Department of Management Services.

## 3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary sources of funding for the Supervision Trust Fund are transfers from the State Board of Administration (as trustee) equivalent to the operations and maintenance portion of the office space rental fees; state facilities parking fees; and interest earnings.

#### B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
