#### B. PRESENT SITUATION:

The Manatee County Fire Prevention Code Enforcement Board and the Manatee County Fire Marshal Appeals Board were created in 1985 with the passage of chapter 85-461, Laws of Florida. The Fire Prevention Code Enforcement Board has the exclusive authority to enforce the fire codes of the fire control districts within the county. The Fire Marshal Appeals Board hears appeals from the decisions of the fire marshals of the fire district within the county. The Enforcement Board and the Appeals Board's annual budgets are derived from a percentage of the fire districts budget in the county. Both of these boards are scheduled to be repealed on July 1, 2001.

### C. EFFECT OF PROPOSED CHANGES:

This bill extends the expiration date of the Manatee County Fire Prevention Code Enforcement Board and the Manatee County Fire Marshal Appeals Board by extending the repeal date of the original special act from July 1, 2001 to July 1, 2006.

#### D. SECTION-BY-SECTION ANALYSIS:

**Section 1.** Section 3 of chapter 85-461, Laws of Florida, as amended by chapters 86-387, 91-387, and 96-446, Laws of Florida, is amended to provide for the act to be repealed on July 1, 2006, rather than July 1, 2001.

**Section 2.** An effective date of upon becoming a law is provided.
