**Senate Amendment (with title amendment)**

On page 4, line 24,

insert:

Section 1. Subsection (2) of section 121.0515, Florida Statutes, is amended to read:

121.0515 Special risk membership.--

(2) CRITERIA.--A member, to be designated as a special risk member, must meet the following criteria:

(a) The member must be employed as a law enforcement officer and be certified, or required to be certified, in compliance with s. 943.1395; however, sheriffs and elected police chiefs shall be excluded from meeting the certification requirements of this paragraph. In addition, the member's duties and responsibilities must include the pursuit, apprehension, and arrest of law violators or suspected law violators; or the member must be an active member of a bomb disposal unit whose primary responsibility is the location, handling, and disposal of explosive devices; or the member

1 must be the supervisor or command officer of a member or  
2 members who have such responsibilities; provided, however,  
3 administrative support personnel, including, but not limited

7 (b) The member must be employed as a firefighter and  
8 be certified, or required to be certified, in compliance with  
9 s. 633.35 and be employed solely within the fire department of

11 government with firefighting responsibilities. In addition,  
12 the member's duties and responsibilities must include  
13 on-the-scene fighting of fires or direct supervision of  
14 firefighting units or aerial firefighting surveillance  
15 performed by fixed-wing pilots employed by the Division of  
16 Forestry of the Department of Agriculture and Consumer  
17 Services, or the member must be the supervisor or command  
18 officer of a member or members who have such responsibilities;  
19 provided, however, administrative support personnel,  
20 including, but not limited to, those whose primary duties and  
21 responsibilities are in accounting, purchasing, legal, and  
22 personnel, shall not be included;

23 (c) The member must be employed as a correctional  
24 officer and be certified, or required to be certified, in

12 emergency medical care. However, administrative support  
13 personnel, including, but not limited to, those whose primary  
14 responsibilities are in accounting, purchasing, legal, and  
15 personnel, shall not be included;

16 (e) The member must be employed as a community-based  
17 correctional probation officer and be certified, or required  
18 to be certified, in compliance with s. 943.1395. In addition,  
19 the member's primary duties and responsibilities must be the  
20 supervised custody, surveillance, control, investigation, and  
21 counseling of assigned inmates, probationers, parolees, or  
22 community controllees within the community; or the member must  
23 be the supervisor of a member or members who have such  
24 responsibilities. Administrative support personnel, including,  
25 but not limited to, those whose primary duties and  
26 responsibilities are in accounting, purchasing, legal  
27 services, and personnel management, shall not be included;  
28 however, probation and parole circuit and deputy circuit
