2 An act relating to the designation of
3 university buildings and facilities;
4 designating the new instruction and research
5 building at Florida Atlantic University's
6 College of Nursing the "Louis and Anne Green
7 Alzheimer's Research Center"; designating the
8 Florida Atlantic University Dania Beach Campus
9 facility the "Kenneth C. Jenne Building";
10 designating the observatory at Florida Gulf
11 Coast University the "Evelyn L. Egan
12 Astronomical Observatory"; designating the
13 student and educational center at Florida Gulf
14 Coast University the "Sugden Welcome Center";
15 designating the building at the Women's Soccer
16 and Softball Complex at Florida State
17 University the "Mary Ann Stiles and Barry Smith
18 Team Building"; designating Building 146 at
19 Florida State University, known as the
20 Molecular Biophysics Building, the "Kasha
21 Laboratory"; designating the University of
22 Central Florida's School of Hospitality
23 Management the "Harris Rosen School of
24 Hospitality Management" and the facility that
25 houses said school "Rosen Hall"; designating
26 the new educational program facility at the
27 Florida Museum of Natural History at the
28 University of Florida the "William W. and
29 Nadine M. McGuire Hall"; designating the new
30 alumni center at the University of Florida the
31 "Emerson Alumni Hall"; designating the new

1 accounting building at the University of
2 Florida's Warrington School of Business the
3 "Gary R. Gerson Hall"; designating the women's
4 gymnasium at the University of Florida the
5 "Kathryn Chicone Ustler Hall"; designating the
6 marine science complex at the University of
7 South Florida's St. Petersburg Campus as the
8 "C.W. 'Bill' Young Marine Science Complex";
9 designating the science research building at
10 Florida Agricultural and Mechanical University
11 as the "Frederick S. Humphries Science and
12 Research Center"; designating the new honors
13 college building at the University of Central
14 Florida as the "Burnett Honors College"; naming
15 the law school at Florida International
16 University the "Rafael Diaz-Balart Building";
17 authorizing the erection of suitable markers;
18 providing an effective date.

20 Be It Enacted by the Legislature of the State of Florida:

21

22 Section 1. The new instruction and research building
23 at Florida Atlantic University's College of Nursing is
24 designated as the "Louis and Anne Green Alzheimer's Research
25 Center."

26 Section 2. The Florida Atlantic University Dania Beach
27 Campus facility is designated as the "Kenneth C. Jenne
28 Building."

29 Section 3. The observatory at Florida Gulf Coast
30 University is designated as the "Evelyn L. Egan Astronomical
31 Observatory."

1 Section 4. The student and educational center at
2 Florida Gulf Coast University is designated as the "Sugden
3 Welcome Center."

4 Section 5. The building at the Women's Soccer and
5 Softball Complex at Florida State University is designated as
6 the "Mary Ann Stiles and Barry Smith Team Building."

7 Section 6. Building 146 at Florida State University,
8 known as the Molecular Biophysics Building, is designated as
9 the "Kasha Laboratory."

10 Section 7. The School of Hospitality Management at the
11 University of Central Florida is designated as the "Harris
12 Rosen School of Hospitality Management" and the facility that
13 houses that school is designated as "Rosen Hall."

14 Section 8. The new educational program facility at the
15 Florida Museum of Natural History at the University of Florida
16 is designated as the "William W. and Nadine M. McGuire Hall."

17 Section 9. The new alumni center at the University of
18 Florida is designated as the "Emerson Alumni Hall."

19 Section 10. The new accounting building at the
20 University of Florida's Warrington School of Business is
21 designated as the "Gary R. Gerson Hall."

22 Section 11. The women's gymnasium at the University of
23 Florida is designated as the "Kathryn Chicone Ustler Hall."

24 Section 12. The marine science complex on the St.
25 Petersburg Campus of the University of South Florida is
26 designated as the "C.W. 'Bill' Young Marine Science Complex."

27 Section 13. The science research building at Florida
28 Agricultural and Mechanical University is designated as the
29 "Frederick S. Humphries Science and Research Center."

1 Section 14. The new honors college building at the
2 University of Central Florida is designated as the "Burnett
3 Honors College."
4 Section 15. The respective universities set forth in
5 this act are authorized to erect suitable markers for the
6 designations made by this act.
7 Section 16. The Law School Building at Florida
8 International University is designated the "Rafael Diaz-Balart
9 Building."
10 Section 17. This act shall take effect upon becoming a
11 law.
