1 A bill to be entitled
2 An act relating to the official Florida
3 Statutes; amending ss. 11.2421, 11.2422,
4 11.2424, and 11.2425, Florida Statutes;
5 adopting the Florida Statutes 2001 and
6 designating the portions thereof that are to
7 constitute the official law of the state;
8 providing that the Florida Statutes 2001 shall
9 be effective immediately upon publication;
10 providing that general laws enacted during the
11 1999 regular session and prior thereto and not
12 included in the Florida Statutes 2001 are
13 repealed; providing that general laws enacted
14 during the January 2000 special session, the
15 2000 regular session, and the 2001 regular
16 session are not repealed by this adoption act.

18 Be It Enacted by the Legislature of the State of Florida:

20 Section 1. Section 11.2421, Florida Statutes, is
21 amended to read:

22 11.2421 Florida Statutes 2001 ~~1999~~ adopted.--The
23 accompanying revision, consolidation, and compilation of the
24 public statutes of 1999 ~~1997~~ of a general and permanent
25 nature, excepting tables, rules, indexes, and other related
26 matter contained therein, prepared by the Office of
27 Legislative Services under the provisions of s. 11.242,
28 together with corrections, changes, and amendments to and
29 repeals of provisions of Florida Statutes 1999 ~~1997~~ enacted in
30 additional reviser's bill or bills by the 2001 ~~1999~~
31 Legislature, is adopted and enacted as the official statute

1 law of the state under the title of "Florida Statutes 2001
2 ~~1999~~" and shall take effect immediately upon publication.
3 Said statutes may be cited as "Florida Statutes 2001 ~~1999~~,"
4 "Florida Statutes," or "F.S. 2001 ~~1999~~."

5 Section 2. Section 11.2422, Florida Statutes, is
6 amended to read:

7 11.2422 Statutes repealed.--Every statute of a general
8 and permanent nature enacted by the State or by the Territory
9 of Florida at or prior to the regular 1999 ~~1997~~ legislative
10 session, and every part of such statute, not included in
11 Florida Statutes 2001 ~~1999~~, as adopted by s. 11.2421, as
12 amended, or recognized and continued in force by reference
13 therein or in ss. 11.2423 and 11.2424, as amended, is
14 repealed.

15 Section 3. Section 11.2424, Florida Statutes, is
16 amended to read:

17 11.2424 Laws not repealed.--Laws enacted at the
18 January 2000 ~~November 1997~~ special session, the 2000 ~~1998~~
19 regular session, and the 2001 ~~1999~~ regular session are not
20 repealed by the adoption and enactment of the Florida Statutes
21 2001 ~~1999~~ by s. 11.2421, as amended, but shall have full
22 effect as if enacted after its said adoption and enactment.

23 Section 4. Section 11.2425, Florida Statutes, is
24 amended to read:

25 11.2425 Rights reserved under repealed statutes.--The
26 repeal of any statute by the adoption and enactment of Florida
27 Statutes 2001 ~~1999~~, by s. 11.2421, as amended, shall not
28 affect any right accrued before such repeal or any civil
29 remedy where a suit is pending.
