or tends to cause such child to become or to remain a 1 2 dependent or delinquent child or a child in need of services, 3 4 commits a misdemeanor of the first degree, punishable as 5 provided in s. 775.082 or s. 775.083. 6 (3) (2) It is not necessary for any court exercising 7 juvenile jurisdiction to make an adjudication that any child 8 is delinquent or dependent or a child in need of services in order to prosecute a violation of this section. An 9 adjudication that a child is delinquent or dependent or a 10 child in need of services shall not preclude a subsequent 11 prosecution of a violation of this section. 12 13 (4) (3) A person 21 years of age or older who 14 impregnates a child under 16 years of age commits an act of child abuse which constitutes a felony of the third degree, 15 punishable as provided in s. 775.082, s. 775.083, or s. 16 775.084. A person who impregnates a child in violation of this 17 subsection commits an offense under this subsection regardless 18 19 of whether the person is found to have committed, or has been 20 charged with or prosecuted for, any other offense committed during the course of the same criminal transaction or episode, 21 including, but not limited to, an offense proscribed under s. 22 800.04, relating to lewd, lascivious, or indecent assault or 23 act upon any person under 16 years of age.
