HOUSE SUMMARY Provides that the prohibition against preparing or dispensing an optical device without first being furnished with a prescription applies regardless of whether the device is to be used for medical or cosmetic purposes. Increases penalties applicable to the unlawful practice of opticianry. Expands inspection authority to cover any establishment in which optical devices are prepared or dispensed. Revises the Criminal Punishment Code to provide an offense severity ranking for the offense of practicing opticianry without a license. See bill for details. bill for details.
