## I. SUMMARY:

HB 701 designates a portion of State Road 16, from the northwestern city limits of Starke in Bradford County to the State Road 121 in Union County as the "Correctional Officers Memorial Highway." It also directs the Florida Department of Transportation (DOT) to erect road markers at either end of the designated segment.

DOT expects to incur an estimated cost of \$500 to erect the two road markers for the new designation.

HB 701 takes effect upon becoming law.

#### **B. PRESENT SITUATION:**

Section 334.071, F.S., explains the process for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not erase the current names of the facilities, nor do they require local governments and private entities to change street signs or addresses. Some public roads and bridges have multiple or overlapping designations.

#### C. EFFECT OF PROPOSED CHANGES:

HB 701 designates that portion of State Road 16 from the northwestern city limits of Starke, in Bradford County, to its intersection with State Road 121, in Union County, as the "Correctional Officers Memorial Highway." It also directs DOT to erect suitable markers.

## D. SECTION-BY-SECTION ANALYSIS:

<u>Section 1:</u> designates a portion of State Road 16 the "Correctional Officers Memorial Highway." Directs DOT to erect suitable markers.

Section 2: Specifies this act shall take effect upon becoming a law.
