18 Section 1. Hillsborough County Tourist Development
19 Council; composition.--Notwithstanding any provision of
20 general law, the Hillsborough County Tourist Development
21 Council shall consist of 11 members. The Chair of the
22 Hillsborough County Board of County Commissioners or any other
23 member as designated by the chair shall serve on the Council.
24 The governing board of Hillsborough County shall appoint an
25 elected municipal official from each municipality within the
26 county to the council. The governing board of the county
27 shall also appoint seven members to the council who are
28 persons involved in the tourist industry and who have
29 demonstrated an interest in tourist development, of which not
30 less than three nor more than four shall be owners or
31 operators of motels, hotels, recreational vehicle parks, or

1 other tourist accommodations in the county and subject to a
 2 tourist development tax. The additional municipal and
 3 industry members shall be appointed within 30 days after the
 4 effective date of this act. The changes in composition of the
 5 membership of the Hillsborough County Tourist Development
 6 Council mandated by the act shall not cause the interruption
 7 of the current term of any person who is a member of the
 8 Hillsborough County Tourist Development Council on the
 9 effective date of this act.

10 Section 2. This act shall take effect upon becoming a
 11 law.
