### I. Summary:

Committee Substitute for Senate Bill 10-C amends s. 859.01, F.S., the statute that punishes poisoning of food, drink, medicine, or certain water supplies, with the intent to kill or injure another person. The amendment expands the scope of the statute to punish a person who, with intent to kill or injure another person, does the following:

- 1. Introduces or adds any poison with food, drink, or medicine;
- 2. Introduces, adds or mingles any bacterium, radioactive material, virus, or chemical compound with food, drink, medicine, or any product designed to be ingested, consumed, or applied to the body; or
- 3. Willfully introduces, adds, or mingles any bacterium, radioactive material, virus, or chemical compound into any spring, well, or reservoir.

This CS amends ss. 859.01 and 921.0022, F.S.

#### II. Present Situation:

Section 859.01, F.S., provides that it is a first degree felony for a person to mingle any poison with food, drink, or medicine with intent to kill or injure another person, or willfully poison any spring, well, or reservoir of water with such intent.

The crime of poisoning in s. 859.01, F.S., is ranked in Level 9 of the Criminal Punishment Code offense severity ranking chart, which is provided in s. 921.0022, F.S.

# III. Effect of Proposed Changes:

Committee Substitute for Senate Bill 10-C amends s. 859.01, F.S., the statute that punishes poisoning of food, drink, medicine, or certain water supplies, with the intent to kill or injure another person. The amendment expands the scope of the statute to punish a person who, with intent to kill or injure another person, does the following:

- 1. Introduces or adds any poison with food, drink, or medicine;
- 2. Introduces, adds or mingles any bacterium, radioactive material, virus, or chemical compound with food, drink, medicine, or any product designed to be ingested, consumed, or applied to the body; or
- 3. Willfully introduces, adds, or mingles any bacterium, radioactive material, virus, or chemical compound into any spring, well, or reservoir.

The CS also amends s. 921.0022, F.S., the Criminal Punishment Code offense severity ranking chart, to amend the description in the chart to reflect the changes made to s. 859.01, F.S., by the CS.

The CS takes effect upon becoming a law.
