An act relating to the City of Cape Coral, Lee County; amending chapter 70-623, Laws of Florida, as amended; extending the territorial limits of the City of Cape Coral; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 2.01 of Article 2 of chapter 70-623, Laws of Florida, as amended by chapter 72-499, Laws of Florida, and as further amended by annexations of certain territory by the City of Cape Coral, is amended to read:

ARTICLE 2-BOUNDARIES

2.01 The territorial limits of said municipality are defined as follows:
