A bill to be entitled 1 2 An act relating to school-age child care; amending s. 411.01, F.S., relating to the 3 4 Florida Partnership for School Readiness and 5 school readiness coalitions; providing for definition of the term "appropriate age of 6 7 self-care"; providing that school-age children 8 meeting specified requirements shall receive 9 priority for participation in school readiness programs; providing an effective date. 10 11 12 Be It Enacted by the Legislature of the State of Florida: 13 14 Section 1. Paragraph (d) of subsection (5) and 15 subsection (6) of section 411.01, Florida Statutes, are 16 amended to read: 17 411.01 Florida Partnership for School Readiness; school readiness coalitions.--18 19 (5) CREATION OF SCHOOL READINESS COALITIONS.--(d) Implementation. --20 1. The school readiness program is to be phased in. 21 22 Until the coalition implements its plan, the county shall 23 continue to receive the services identified in subsection (3) 24 through the various agencies that would be responsible for delivering those services under current law. Plan 25 implementation is subject to approval of the coalition and the 26 27 plan by the Florida Partnership for School Readiness. 28 2. Each school readiness coalition shall develop a 29 plan for implementing the school readiness program to meet the 30 requirements of this section and the performance standards and outcome measures established by the partnership. The plan must 31 1

include a written description of the role of the program in 1 2 the coalition's effort to meet the first state education goal, readiness to start school, including a description of the plan 3 to involve the prekindergarten early intervention programs, 4 5 Head Start Programs, programs offered by public or private 6 providers of child care, preschool programs for children with 7 disabilities, programs for migrant children, Title I programs, 8 subsidized child care programs, and teen parent programs. The 9 plan must also demonstrate how the program will ensure that 10 each 3-year-old and 4-year-old child in a publicly funded 11 school readiness program receives scheduled activities and 12 instruction designed to prepare children to enter kindergarten 13 ready to learn. Prior to implementation of the program, the 14 school readiness coalition must submit the plan to the partnership for approval. The partnership may approve the 15 16 plan, reject the plan, or approve the plan with conditions. The Florida Partnership for School Readiness shall review 17 coalition plans at least annually. 18

19 3. The plan for the school readiness program must20 include the following minimum standards and provisions:

a. A sliding fee scale establishing a copayment for
parents based upon their ability to pay, which is the same for
all program providers, to be implemented and reflected in each
program's budget.

b. A choice of settings and locations in licensed,
registered, religious-exempt, or school-based programs to be
provided to parents.

28 c. Instructional staff who have completed the training 29 course as required in s. 402.305(2)(d)1., as well as staff who 30 have additional training or credentials as required by the 31

partnership. The plan must provide a method for assuring the
 qualifications of all personnel in all program settings.

3 d. Specific eligibility priorities for children within4 the coalition's county pursuant to subsection (6).

e. Performance standards and outcome measures
established by the partnership or alternatively, standards and
outcome measures to be used until such time as the partnership
adopts such standards and outcome measures.

9 f. Reimbursement rates that have been developed by the 10 coalition. Reimbursement rates shall not have the effect of 11 limiting parental choice or creating standards or levels of 12 services that have not been authorized by the Legislature.

13 g. Systems support services, including a central 14 agency, child care resource and referral, eligibility 15 determinations, training of providers, and parent support and 16 involvement.

h. Direct enhancement services to families and
children. System support and direct enhancement services shall
be in addition to payments for the placement of children in
school readiness programs.

i. A business plan, which must include the contract
with a school readiness agent if the coalition is not a
legally established corporate entity. Coalitions may contract
with other coalitions to achieve efficiency in multiple-county
services, and such contracts may be part of the coalition's
business plan.

j. Strategies to meet the needs of unique populations,such as migrant workers.

1 As part of the plan, the coalition may request the Governor to 2 apply for a waiver to allow the coalition to administer the 3 Head Start Program to accomplish the purposes of the school readiness program. If any school readiness plan can 4 5 demonstrate that specific statutory goals can be achieved more effectively by using procedures that require modification of 6 7 existing rules, policies, or procedures, a request for a waiver to the partnership may be made as part of the plan. 8 9 Upon review, the partnership may grant the proposed modification. 10

4. Persons with an early childhood teaching
 certificate may provide support and supervision to other staff
 in the school readiness program.

14 5. The coalition may not implement its plan until it 15 submits the plan to and receives approval from the 16 partnership. Once the plan has been approved, the plan and the 17 services provided under the plan shall be controlled by the 18 coalition rather than by the state agencies or departments. 19 The plan shall be reviewed and revised as necessary, but at 20 least biennially.

21 6. The following statutes will not apply to local 22 coalitions with approved plans: ss. 125.901(2)(a)3., 411.221, and 411.232. To facilitate innovative practices and to allow 23 local establishment of school readiness programs, a school 24 readiness coalition may apply to the Governor and Cabinet for 25 26 a waiver of, and the Governor and Cabinet may waive, any of 27 the provisions of ss. 230.23166, 411.223, and 411.232, if the 28 waiver is necessary for implementation of the coalition's 29 school readiness plan.

30 7. Two or more counties may join for the purpose of31 planning and implementing a school readiness program.

A coalition may, subject to approval of the 1 8. 2 partnership as part of the coalition's plan, receive 3 subsidized child care funds for all children eligible for any federal subsidized child care program and be the provider of 4 5 the program services. 9. Coalitions are authorized to enter into multiparty 6 7 contracts with multicounty service providers in order to meet 8 the needs of unique populations such as migrant workers. 9 (6) PROGRAM ELIGIBILITY. -- The school readiness program 10 shall be established for children under the age of 11 kindergarten eligibility.Priority for participation in the school readiness program shall be given to children who meet 12 13 one or more of the following criteria: (a) Children under the age of kindergarten eligibility 14 15 who are: Children determined to be at risk of abuse, 16 1. neglect, or exploitation and who are currently clients of the 17 Family Safety Program Office of the Department of Children and 18 19 Family Services. 20 2. Children at risk of welfare dependency, including economically disadvantaged children, children of participants 21 22 in the welfare transition program, children of migrant farmworkers, and children of teen parents. 23 24 3. Children of working families whose family income 25 does not exceed 150 percent of the federal poverty level. 26 (b) Three-year-old children and 4-year-old children 27 who may not be economically disadvantaged but who have 28 disabilities, have been served in a specific part-time or 29 combination of part-time exceptional education programs with 30 required special services, aids, or equipment, and were 31

previously reported for funding part time with the Florida 1 2 Education Finance Program as exceptional students. 3 (c) Economically disadvantaged children, children with 4 disabilities, and children at risk of future school failure, 5 from birth to 4 years of age, who are served at home through 6 home visitor programs and intensive parent education programs 7 such as the Florida First Start Program. 8 (d) Children who meet federal and state requirements 9 for eligibility for the migrant preschool program but who do not meet the criteria of economically disadvantaged. 10 11 (e) Children under 12 years of age: who are determined 12 to be at risk of abuse, neglect, or exploitation; whose 13 parents are participating in a welfare transition or diversion 14 program; who are children of working families whose family income does not exceed 150 percent of the federal poverty 15 16 level; who have special needs pursuant to paragraph (b); or who have a sibling under 5 years of age who is eligible for 17 participation in a school readiness program pursuant to 18 19 paragraphs (a)-(d). Priority for eligibility pursuant to this 20 paragraph shall be given to those children who are under the appropriate age of self-care, as defined by the coalition in 21 22 its school readiness plan. 23 24 An "economically disadvantaged" child means a child whose 25 family income is below 150 percent of the federal poverty 26 level. Notwithstanding any change in a family's economic 27 status, but subject to additional family contributions in accordance with the sliding fee scale, a child who meets the 28 29 eligibility requirements upon initial registration for the program shall be considered eligible until the child reaches 30

the age of self-care or 12 years of age, as specified by the coalition in its school readiness plan kindergarten age. Section 2. This act shall take effect July 1, 2002. б HOUSE SUMMARY Provides that school-age children who meet specified requirements shall be given priority for participation in school readiness programs administered by school readiness coalitions.
