insert:

Section 4. Subsection (4) of section 240.299, Florida Statutes, is amended to read:

240.299 Direct-support organizations; use of property; board of directors; activities; audit; facilities.--

(4) ACTIVITIES; RESTRICTION.--A university direct-support organization is prohibited from giving, either directly or indirectly, any gift to a political committee or committee of continuous existence as defined in s. 106.011 ~~for any purpose other than those certified by a majority roll call vote of the governing board of the direct-support organization at a regularly scheduled meeting as being directly related to the educational mission of the university. Any gift by a direct-support organization, either direct or indirect, with a value in excess of \$1000 must be immediately reported to the~~ university board of trustees. The report must include the
