B. PRESENT SITUATION:

Supervisors of elections are not currently required to establish polling places at state universities. However, some supervisors have voluntarily established polling places at the state universities, including Leon (Florida A&M University, Florida State University) and Alachua Counties.¹

Students must live in the precinct to vote at these polling locations, so if they live off of campus, they would have to vote in another precinct. Alachua County reports that the turnout at the polling place on the University of Florida campus is significantly lower than its other precincts.²

In addition, some students if registered, vote by absentee ballot from their home county of residence.

C. EFFECT OF PROPOSED CHANGES:

HB 1201 amends s. 101.001, F.S., relating to precincts and polling places. It requires that supervisors of elections in each county where the main campus of a state university is located establish a polling place on that campus.

The bill is effective July 1, 2003.
