Section 2. Effective July 1, 2004, section 400.4786, Florida Statutes, is created to read:

400.4786 Care for persons with Alzheimer's disease or 27 related disorders.--

(1) As a condition of licensure, home health agencies licensed under this part must provide to each of their employees, upon beginning employment, basic written

information about interacting with persons with Alzheimer's disease or a related disorder.

- (2) All employees who are expected to, or whose responsibilities require them to, have direct contact with clients with Alzheimer's disease or a related disorder must, in addition to being provided the information required in this section, also have an initial training of at least 1 hour completed in the first 3 months after beginning employment. This training must include, but is not limited to, an overview of dementias and must provide basic skills in communicating with persons with dementia.
- with Alzheimer's disease or a related disorder shall be considered a direct caregiver and must complete the required 1-hour training and an additional 3 hours of training within 9 months after beginning to work with the home health agency. - (2) All employees who are expected to, or whose responsibilities require them to, have direct contact with clients with Alzheimer's disease or a related disorder must, in addition to being provided the information required in this

section, also have an initial training of at least 1 hour completed in the first 3 months after beginning employment.

This training must include, but is not limited to, an overview of dementias and must provide basic skills in communicating with persons with dementia.

- (3) An individual who provides direct care shall be considered a direct caregiver and must complete the required 1-hour training and an additional 3 hours of training within 9 months after beginning employment. 400.6045 Patients with Alzheimer's disease or other related disorders; certain disclosures; training.--

(1) A hospice licensed under this part which claims that it provides special care for persons who have Alzheimer's disease or other related disorders must disclose in its advertisements or in a separate document those services that distinguish the care as being especially applicable to, or suitable for, such persons. The hospice must give a copy of all such advertisements or a copy of the document to each person who requests information about programs and services for persons with Alzheimer's disease or other related disorders offered by the hospice and must maintain a copy of all such advertisements and documents in its records. The agency shall examine all such advertisements and documents in the hospice's records as part of the license renewal procedure. (2) A hospice licensed under this part must provide to each of its employees, upon beginning employment, basic written information about interacting with persons with Alzheimer's disease or a related disorder.

- (3) All employees who are expected to, or whose responsibilities require them to, have direct contact with patients with Alzheimer's disease or a related disorder must, in addition to being provided the information required in this section, have an initial training of at least 1 hour completed in the first 3 months after beginning employment. This training shall include, but not be limited to, an overview of dementias and shall provide basic skills in communicating with persons with dementia.
- with Alzheimer's disease or a related disorder shall be considered a direct caregiver and must complete the required 1-hour training and an additional 3 hours of training within 9 months after beginning to work with the hospice. This training shall include, but not be limited to, managing problem behaviors, promoting the patient's independence in activities of daily living, and skills in working with families and caregivers.

Section 7. The Department of Elderly Affairs or its designee must approve the initial and continuing training provided pursuant to this act. The department shall keep a list of current providers who are approved to provide initial and continuing training. The department shall adopt rules to

establish standards for the trainers and the training required 2 in this act. Any trainer approved pursuant to this act shall be considered to be an approved trainer for the purposes of 3 4 meeting the Alzheimer's training requirements for any entity 5 licensed under chapter 400, Florida Statutes. Any training 6 curricula approved pursuant to this act shall be considered to 7 meet the Alzheimer's training requirements for any entity licensed under chapter 400, Florida Statutes, except that the 8 approved training curricula shall be considered to meet only a 9 part of the Alzheimer's training requirements for assisted 10 living facilities licensed under part III of chapter 400, 11 12 Florida Statutes. A trainer shall submit to the department or 13 its designee the additional curricula necessary to meet the 14 Alzheimer's training requirements set forth in s. 400.4178, 15 Florida Statutes, for employees of assisted living facilities. 16 The department shall apply the training completed by employees 17 who meet the Alzheimer's training requirements for any entity licensed pursuant to part II, part IV, part V, part VI, or 18 19 part VII of chapter 400, Florida Statutes, toward the 20 completion of the additional Alzheimer's training required in 21 s. 400.4178, Florida Statutes. The Legislature finds that Alzheimer's 22 Section 8. 23 disease and related disorders pose an urgent health need in this state. Therefore, each state university, college, or 24 postsecondary school that prepares undergraduate or graduate 25 26 students for health professions as described in chapter 456, 27 Florida Statutes, is encouraged to include in its curriculum basic training about Alzheimer's disease and related 28 29 disorders. Section 9. Except as otherwise provided herein, this 30 act shall take effect July 1, 2002. 31
