The School of Business and Industry 13 building at Florida Agricultural and Mechanical University is 14 designated as the "Sybil C. Mobley Business Building." 15 Section 3. The new allied health building at Florida 16 Agricultural and Mechanical University is designated as the 17 "Jacqueline B. Beck-Margaret W. Lewis Allied Health Building." Section 4. The architecture building at Florida 18 19 Agricultural and Mechanical University is designated as the 20 "Walter L. Smith Architecture Building." Section 5. The building which houses the University of 21 22 Central Florida Downtown Center is designated as the "James and Annie Ying Academic Center." 23 24 Section 6. The student/community educational facility 25 for health at Florida Gulf Coast University is designated as 26 the "Kleist Health Education Center." 27 Section 7. The new gymnasium/athletics facility at 28 Florida Gulf Coast University is designated as the "Alico Arena." 29 30 Section 8. The new demonstration and education model building to promote environmentally sustainable living

conditions at Florida Gulf Coast University is designated as the "WCI Green Building Demonstration and Learning Center." Section 9. The new foundation building to be erected on the Palmer Campus of New College is designated as the "Keating Center." Section 10. The new nursing building on the Boca Raton Campus of Florida Atlantic University is designated as the 'Christine E. Lynn Nursing Building." Section 11. This act shall take effect upon becoming a law.
