Short title. -- This act may be cited as the "Officer Malcolm Thompson Act." 26 27 Section 2. It is declared by the Legislature that firefighters, paramedics, emergency medical technicians, and 28

continuously instruct school personnel, public officials, and private citizens about safety; and that their activities are 2 3 vital to the public safety. Therefore, the Legislature declares that it is a proper and legitimate state purpose to 4 provide a uniform retirement system for the benefit of firefighters, paramedics, emergency medical technicians, and police officers as defined in this act and intends, in implementing the provisions of Section 14, Article X of the State Constitution as they relate to municipal and special 10 district pension trust fund systems and plans, that such 11 retirement systems or plans be managed, administered, operated, and funded in such manner as to maximize the 12 protection of pension trust funds. Pursuant to Section 18, 13 Article VII of the State Constitution, the Legislature hereby 14 determines and declares that the provisions of this act 15 fulfill an important state interest. 16 17

Section 3. Paragraph (b) of subsection (4) and paragraph (b) of subsection (9) of section 121.091, Florida Statutes, are amended to read:

121.091 Benefits payable under the system.--Benefits may not be paid under this section unless the member has terminated employment as provided in s. 121.021(39)(a) or begun participation in the Deferred Retirement Option Program as provided in subsection (13), and a proper application has been filed in the manner prescribed by the department. The department may cancel an application for retirement benefits when the member or beneficiary fails to timely provide the information and documents required by this chapter and the department's rules. The department shall adopt rules establishing procedures for application for retirement

benefits and for the cancellation of such application when the required information or documents are not received.

- (4) DISABILITY RETIREMENT BENEFIT. --
- (b) Total and permanent disability. -- A member shall be considered totally and permanently disabled if, in the opinion of the administrator, he or she is prevented, by reason of a medically determinable physical or mental impairment, from rendering useful and efficient service as an officer or employee. A Special Risk Class member who is an officer as defined in s. 943.10(1), (2), or (3); a firefighter as defined in s. 633.30(1); an emergency medical technician as defined in s. 401.23(11); or a paramedic as defined in s. 401.23(17) who is catastrophically injured as defined in s. 440.02(37) in the line of duty as a result of a felonious act of another shall be considered totally and permanently disabled and unable to render useful and efficient service as an officer, unless the administrator can provide documented competent medical evidence that the officer is able to render useful and efficient service as an employee.
  - (9) EMPLOYMENT AFTER RETIREMENT; LIMITATION. --
- (b)1. Any person who is retired under this chapter, except under the disability retirement provisions of subsection (4), may be reemployed by any private or public employer after retirement and receive retirement benefits and compensation from his or her employer without any limitations, except that a person may not receive both a salary from reemployment with any agency participating in the Florida Retirement System and retirement benefits under this chapter for a period of 12 months immediately subsequent to the date of retirement. However, a DROP participant shall continue 31 employment and receive a salary during the period of

30 31 participation in the Deferred Retirement Option Program, as provided in subsection (13).

- 2. Any person to whom the limitation in subparagraph 1. applies who violates such reemployment limitation and who is reemployed with any agency participating in the Florida Retirement System before completion of the 12-month limitation period shall give timely notice of this fact in writing to the employer and to the division and shall have his or her retirement benefits suspended for the balance of the 12-month limitation period. Any person employed in violation of this paragraph and any employing agency which knowingly employs or appoints such person without notifying the Division of Retirement to suspend retirement benefits shall be jointly and severally liable for reimbursement to the retirement trust fund of any benefits paid during the reemployment limitation period. To avoid liability, such employing agency shall have a written statement from the retiree that he or she is not retired from a state-administered retirement system. Any retirement benefits received while reemployed during this reemployment limitation period shall be repaid to the retirement trust fund, and retirement benefits shall remain suspended until such repayment has been made. Benefits suspended beyond the reemployment limitation shall apply toward repayment of benefits received in violation of the reemployment limitation.
- 3. A district school board may reemploy a retired member as a substitute or hourly teacher, education paraprofessional, transportation assistant, bus driver, or food service worker on a noncontractual basis after he or she has been retired for 1 calendar month, in accordance with s. 121.021(39). Any retired member who is reemployed within 1

calendar month after retirement shall void his or her application for retirement benefits. District school boards 2 3 reemploying such teachers, education paraprofessionals, 4 transportation assistants, bus drivers, or food service 5 workers are subject to the retirement contribution required by 6 subparagraph 8.7. Reemployment of a retired member as a 7 substitute or hourly teacher, education paraprofessional, transportation assistant, bus driver, or food service worker 8 9 is limited to 780 hours during the first 12 months of his or 10 her retirement. Any retired member reemployed for more than 11 780 hours during his or her first 12 months of retirement shall give timely notice in writing to the employer and to the 12 division of the date he or she will exceed the limitation. 13 The division shall suspend his or her retirement benefits for 14 the remainder of the first 12 months of retirement. Any 15 person employed in violation of this subparagraph and any 16 17 employing agency which knowingly employs or appoints such person without notifying the Division of Retirement to suspend 18 19 retirement benefits shall be jointly and severally liable for 20 reimbursement to the retirement trust fund of any benefits paid during the reemployment limitation period. To avoid 21 22 liability, such employing agency shall have a written statement from the retiree that he or she is not retired from 23 24 a state-administered retirement system. Any retirement 25 benefits received by a retired member while reemployed in excess of 780 hours during the first 12 months of retirement 26 shall be repaid to the Retirement System Trust Fund, and his 27 28 or her retirement benefits shall remain suspended until 29 repayment is made. toward repayment of benefits received in violation of the 780-hour reemployment limitation.

4. A community college board of trustees may reemploy a retired member as an adjunct instructor, that is, an instructor who is noncontractual and part-time, or as a participant in a phased retirement program within the Florida Community College System, after he or she has been retired for 1 calendar month, in accordance with s. 121.021(39). Any retired member who is reemployed within 1 calendar month after retirement shall void his or her application for retirement benefits. Boards of trustees reemploying such instructors are subject to the retirement contribution required in subparagraph 8.7.A retired member may be reemployed as an adjunct instructor for no more than 780 hours during the first 12 months of retirement. Any retired member reemployed for more than 780 hours during the first 12 months of retirement shall give timely notice in writing to the employer and to the division of the date he or she will exceed the limitation. The division shall suspend his or her retirement benefits for the remainder of the first 12 months of retirement. Any person employed in violation of this subparagraph and any employing agency which knowingly employs or appoints such person without notifying the Division of Retirement to suspend retirement benefits shall be jointly and severally liable for reimbursement to the retirement trust fund of any benefits paid during the reemployment limitation period. To avoid liability, such employing agency shall have a written statement from the retiree that he or she is not retired from a state-administered retirement system. Benefits suspended beyond the end of the retired member's first 12 months of retirement shall apply toward repayment of benefits received in violation of the 780-hour reemployment limitation.

The State University System may reemploy a retired member as an adjunct faculty member or as a participant in a phased retirement program within the State University System after the retired member has been retired for 1 calendar month, in accordance with s. 121.021(39). Any retired member who is reemployed within 1 calendar month after retirement shall void his or her application for retirement benefits. The State University System is subject to the retired contribution required in subparagraph 8.7., as appropriate. A retired member may be reemployed as an adjunct faculty member or a participant in a phased retirement program for no more than 780 hours during the first 12 months of his or her retirement. Any retired member reemployed for more than 780 hours during the first 12 months of retirement shall give timely notice in writing to the employer and to the division of the date he or she will exceed the limitation. The division shall suspend his or her retirement benefits for the remainder of the first 12 months of retirement. Any person employed in violation of this subparagraph and any employing agency which knowingly employs or appoints such person without notifying the Division of Retirement to suspend retirement benefits shall be jointly and severally liable for reimbursement to the retirement trust fund of any benefits paid during the reemployment limitation period. To avoid liability, such employing agency shall have a written

statement from the retiree that he or she is not retired from a state-administered retirement system. Any retirement benefits received by a retired member while reemployed in excess of 780 hours during the first 12 months of retirement shall be repaid to the Retirement System Trust Fund, and retirement benefits shall remain suspended until repayment is made. Benefits suspended beyond the end of the retired member's first 12 months of retirement shall apply toward repayment of benefits received in violation of the 780-hour reemployment limitation.

The Board of Trustees of the Florida School for the Deaf and the Blind may reemploy a retired member as a substitute teacher, substitute residential instructor, or substitute nurse on a noncontractual basis after he or she has been retired for 1 calendar month, in accordance with s. 121.021(39). Any retired member who is reemployed within 1 calendar month after retirement shall void his or her application for retirement benefits. The Board of Trustees of the Florida School for the Deaf and the Blind reemploying such teachers, residential instructors, or nurses is subject to the retirement contribution required by subparagraph 8.7. Reemployment of a retired member as a substitute teacher, substitute residential instructor, or substitute nurse is limited to 780 hours during the first 12 months of his or her retirement. Any retired member reemployed for more than 780 hours during the first 12 months of retirement shall give timely notice in writing to the employer and to the division of the date he or she will exceed the limitation. The division shall suspend his or her retirement benefits for the remainder of the first 12 months of retirement. Any person employed in 31 violation of this subparagraph and any employing agency which

knowingly employs or appoints such person without notifying 2 the Division of Retirement to suspend retirement benefits 3 shall be jointly and severally liable for reimbursement to the retirement trust fund of any benefits paid during the 4 5 reemployment limitation period. To avoid liability, such 6 employing agency shall have a written statement from the 7 retiree that he or she is not retired from a state-administered retirement system. Any retirement benefits 8 9 received by a retired member while reemployed in excess of 780 10 hours during the first 12 months of retirement shall be repaid 11 to the Retirement System Trust Fund, and his or her retirement benefits shall remain suspended until payment is made. 12 Benefits suspended beyond the end of the retired member's 13 first 12 months of retirement shall apply toward repayment of 14 benefits received in violation of the 780-hour reemployment 15 limitation. 16 17

7. A sheriff may reemploy a retired member as a deputy sheriff after the retired member has been retired for 1 calendar month, in accordance with s. 121.021(39). Any retired member who is reemployed within 1 calendar month after retirement shall void his or her application for retirement benefits. Sheriffs reemploying such deputy sheriffs are subject to the retirement contribution required in subparagraph 8. Reemployment of a retired deputy sheriff is limited to no more than 780 hours during the first 12 months of his or her retirement. Any retired member reemployed for more than 780 hours during the first 12 months of retirement shall give timely notice in writing to the employer and to the division of the date he or she will exceed the limitation. The division shall suspend his or her retirement benefits for the remainder of the first 12 months of retirement. Any person

employed in violation of this subparagraph and any employing agency that knowingly employs or appoints such person without 2 3 notifying the Division of Retirement to suspend retirement benefits shall be jointly and severally liable for 4 5 reimbursement to the retirement trust fund of any benefits 6 paid during the reemployment limitation period. To avoid 7 liability, such employing agency must have a written statement 8 from the retiree that he or she is not retired from a state-administered retirement system. Any retirement benefits 9 10 received by a retired member while reemployed in excess of 780 11 hours during the first 12 months of retirement shall be repaid to the Retirement System Trust Fund, and retirement benefits 12 shall remain suspended until repayment is made. Benefits 13 suspended beyond the end of the retired member's first 12 14 months of retirement shall apply toward repayment of benefits 15 received in violation of the 780-hour reemployment limitation. 16 17 8.7. The employment by an employer of any retiree or DROP participant of any state-administered retirement system 18 19 shall have no effect on the average final compensation or years of creditable service of the retiree or DROP 20 21 participant. Prior to July 1, 1991, upon employment of any person, other than an elected officer as provided in s. 22 121.053, who has been retired under any state-administered 23 24 retirement program, the employer shall pay retirement 25 contributions in an amount equal to the unfunded actuarial liability portion of the employer contribution which would be 26 required for regular members of the Florida Retirement System. 27 28 Effective July 1, 1991, contributions shall be made as 29 provided in s. 121.122 for retirees with renewed membership or 30 subsection (13) with respect to DROP participants. 31

9.8. Any person who has previously retired and who is holding an elective public office or an appointment to an elective public office eligible for the Elected Officers' Class on or after July 1, 1990, shall be enrolled in the Florida Retirement System as provided in s. 121.053(1)(b) or, if holding an elective public office that does not qualify for the Elected Officers' Class on or after July 1, 1991, shall be enrolled in the Florida Retirement System as provided in s. 121.122, and shall continue to receive retirement benefits as well as compensation for the elected officer's service for as long as he or she remains in elective office. However, any retired member who served in an elective office prior to July 1, 1990, suspended his or her retirement benefit, and had his or her Florida Retirement System membership reinstated shall, upon retirement from such office, have his or her retirement benefit recalculated to include the additional service and compensation earned.

10.9. Any person who is holding an elective public office which is covered by the Florida Retirement System and who is concurrently employed in nonelected covered employment may elect to retire while continuing employment in the elective public office, provided that he or she shall be required to terminate his or her nonelected covered employment. Any person who exercises this election shall receive his or her retirement benefits in addition to the compensation of the elective office without regard to the time limitations otherwise provided in this subsection. No person who seeks to exercise the provisions of this subparagraph, as the same existed prior to May 3, 1984, shall be deemed to be retired under those provisions, unless such person is eligible

11.10. The limitations of this paragraph apply to reemployment in any capacity with an "employer" as defined in s. 121.021(10), irrespective of the category of funds from which the person is compensated.

12. An employing agency may reemploy a retired member as a firefighter or paramedic after the retired member has been retired for 1 calendar month, in accordance with s. 121.021(39). Any retired member who is reemployed within 1 calendar month after retirement shall void his or her application for retirement benefits. Employing agencies reemploying such firefighters or paramedics are subject to the retirement contribution required in subparagraph 8. Reemployment of a retired firefighter or paramedic is limited to no more than 780 hours during the first 12 months of his or her retirement. Any retired member reemployed for more than 780 hours during the first 12 months of retirement shall give timely notice in writing to the employer and to the division of the date he or she will exceed the limitation. The division shall suspend his or her retirement benefits for the remainder of the first 12 months of retirement. A person employed in violation of this subparagraph and an employing agency that knowingly employs or appoints such person without notifying the Division of Retirement to suspend retirement benefits shall be jointly and severally liable for reimbursement to the retirement trust fund of any benefits paid during the reemployment limitation period. To avoid liability, such employing agency must have a written statement from the retiree that he or she is not retired from a

Section 4. Subsection (5) of section 175.191, Florida Statutes, is amended to read:

175.191 Disability retirement.--For any municipality, special fire control district, chapter plan, local law municipality, local law special fire control district, or local law plan under this chapter:

(5) The benefit payable to a firefighter who retires from the service of a municipality or special fire control district due to total and permanent disability as a direct result of a disability is the monthly income payable for 10 years certain and life for which, if the firefighter's disability occurred in the line of duty, his or her monthly benefit shall be the accrued retirement benefit, but shall not be less than 42 percent of his or her average monthly salary at the time of disability. If after 10 years of service the disability is other than in the line of duty, the firefighter's monthly benefit shall be the accrued normal retirement benefit, but shall not be less than 25 percent of his or her average monthly salary at the time of disability. Notwithstanding any provision to the contrary, the monthly retirement benefit payable to a firefighter, emergency medical technician, or paramedic who retires from service due to total and permanent disability as a result of a catastrophic injury as defined in s. 440.02(37) suffered in the line of duty where

Section 5. Subsection (5) of section 185.18, Florida Statutes, is amended to read:

185.18 Disability retirement.--For any municipality, chapter plan, local law municipality, or local law plan under this chapter:

(5) The benefit payable to a police officer who retires from the service of the city with a total and permanent disability as a result of a disability is the monthly income payable for 10 years certain and life for which, if the police officer's disability occurred in the line of duty, his or her monthly benefit shall be the accrued retirement benefit, but shall not be less than 42 percent of his or her average monthly compensation as of the police officer's disability retirement date. If after 10 years of service the disability is other than in the line of duty, the police officer's monthly benefit shall be the accrued normal retirement benefit, but shall not be less than 25 percent of his or her average monthly compensation as of the police officer's disability retirement date. Notwithstanding any provision to the contrary, the monthly retirement benefit payable to a police officer who retires from service due to total and permanent disability as a result of a catastrophic injury as defined in s. 440.02(37) suffered in the line of duty where such injury is a result of a felonious act of another shall be the accrued retirement benefit but shall not be less than 80 percent of the officer's average monthly compensation as of the officer's disability retirement date.

1	Section 6. Effective July 1, 2002, in order to fund
2	the benefits provided in section 121.091, Florida Statutes, as
3	amended by this act:
4	(1) The contribution rate that applies to the Special
5	Risk Class of the defined benefit program of the Florida
6	Retirement System shall be increased by 0.02 percentage
7	points; and
8	(2) The contribution rate that applies to the Special
9	Risk Administrative Support Class of the defined benefit
10	program of the Florida Retirement System shall be increased by
11	0.14 percentage points.

13	These increases shall be in addition to all other changes to
14	such contribution rates which may be enacted into law to take
15	effect on that date. The Division of Statutory Revision is
16	directed to adjust accordingly the contribution rates set
17	forth in section 121.071, Florida Statutes.
18	Section 7. Except as otherwise provided in this act,
19	this act shall take effect upon becoming a law.
