23	Section 1. Section 380.276, Florida Statutes, is

28	(1) It is the intent of the Legislature that a
29	cooperative effort among state agencies and local governments
30	be undertaken to plan for and assist in the display of uniform
31	warning and safety flags, and the placement of uniform

notification signs that provide the meaning of such warning and safety flags, on the public beaches along the coast of the state. Because the varying natural conditions of Florida's public beaches and coastal areas pose significant risks to the safety of tourists and the general public, it is important to inform the public of the need to exercise caution.

- The Department of Community Affairs, through the (2) Florida Coastal Management Program, shall direct and coordinate the uniform warning and safety flag program. The purpose of the program shall be to encourage the display of uniform warning and safety flags at all public beaches along the coast of the state at which warning and safety flags are displayed and lifequards are on duty, and to encourage the placement of uniform notification signs that provide the meaning of such flags.
- (3) The Department of Community Affairs shall develop a program for the display of uniform warning and safety flags at all public beaches along the coast of the state at which warning and safety flags are displayed and lifeguards are on duty, and for the placement of uniform notification signs that provide the meaning of the flags displayed. Such a program shall provide:
- (a) For posted notification of the meaning of each of the warning and safety flags at all designated public access points.
- That uniform notification signs be posted in a conspicuous location and be clearly legible.
- (c) A standard size, shape, color, and definition for each warning and safety flag.
- (d) That flags incorporate a numerical designation to 31 accommodate persons who are colorblind.

- (e) That flags not specifically defined by the department must be identified by the entity displaying the flags in the posted notification.
 - Guidelines for the periodic replacement of flags.
- The Department of Community Affairs is authorized, (4)within the limits of appropriations available to it for such purposes, to establish and operate a program to encourage the display of uniform warning and safety flags on all public beaches along the coast of the state and to encourage the placement of uniform notification signs that provide the meaning of the flags displayed. The department shall coordinate the implementation of the uniform warning and safety flag program with local governing bodies and the Florida Beach Patrol Chiefs Association.
- The Department of Community Affairs may adopt rules pursuant to ss. 120.536(1) and 120.54 necessary to administer this section.
- The state, state agencies, local governments, and (6) local government agencies may not be held liable for any injury caused by the reasonable placement or location of uniform warning and safety flags or reasonably posted uniform notification signs or the failure to install uniform warning and safety flags or posted uniform notification signs as provided by this section.

Section 2. This act shall take effect July 1, 2002.

4	Charges the Department of Community Affairs, through the
5	Florida Coastal Management Program, rather than the Department of Health, with the responsibility of developing a program for
6	the display of uniform warning flags and explanatory signs at coastal beaches at which flags are displayed and lifequards
7	are on duty.
8	Provides that state and local governments cannot be held liable for injuries caused by the reasonable placement or
9	location of safety and warning flags or notification signs.
