25-1045-02 A bill to be entitled 1 2 An act relating to secondary education; amending s. 232.246, F.S.; revising the options 3 4 for fulfilling the physical-education 5 requirement for high-school graduation; 6 providing an effective date. 7 8 Be It Enacted by the Legislature of the State of Florida: 9 10 Section 1. Paragraph (j) of subsection (1) of section 232.246, Florida Statutes, is amended to read: 11 12 232.246 General requirements for high school graduation. --13 (1) Graduation requires successful completion of 14 either a minimum of 24 academic credits in grades 9 through 12 15 16 or an International Baccalaureate curriculum. The 24 credits shall be distributed as follows: 17 (j)1. One credit in physical education to include 18 19 assessment, improvement, and maintenance of personal fitness. 20 Participation in an interscholastic sport at the junior 21 varsity or varsity level, for two full seasons, shall satisfy 22 the one-credit requirement in physical education if the student passes a competency test on personal fitness with a 23 score of "C" or better. The competency test on personal 24 25 fitness must be developed by the Department of Education. A 26 school board may not require that the one credit in physical 27 education be taken during the 9th grade year. 28 2. Completion of one semester with a grade of "C" or 29 better in a marching band class, or in a physical activity 30 class such as eurhythmics, which requires participation in marching band activities as an extracurricular activity shall 31 1

satisfy a one-half-credit requirement in physical education. 1 2 This half credit may not be used to satisfy the 3 personal-fitness requirement nor the requirement for adaptive 4 physical education under an individual education plan (IEP) or 5 504 plan. 6 7 School boards may award a maximum of one-half credit in social studies and one-half elective credit for student completion of 8 9 nonpaid voluntary community or school service work. Students 10 choosing this option must complete a minimum of 75 hours of 11 service in order to earn the one-half credit in either category of instruction. Credit may not be earned for service 12 provided as a result of court action. School boards that 13 approve the award of credit for student volunteer service 14 15 shall develop guidelines regarding the award of the credit, and school principals are responsible for approving specific 16 17 volunteer activities. A course designated in the Course Code Directory as grade 9 through grade 12 which is taken below the 18 19 9th grade may be used to satisfy high school graduation requirements or Florida Academic Scholars award requirements 20 as specified in a district's pupil progression plan. A student 21 shall be granted credit toward meeting the requirements of 22 this subsection for equivalent courses, as identified pursuant 23 24 to s. 229.551(1)(f)6., taken through dual enrollment. 25 Section 2. This act shall take effect July 1, 2002. 26 27 28 SENATE SUMMARY Allows the physical-education requirement for high-school graduation to be partly satisfied by satisfactory participation in marching-band activities. 29 30 31
