The department's obligation to fund 13 the automation of the depositories is limited to the state share of funds available in the Clerk of the Court Child 14 15 Support Enforcement Collection System Trust Fund. depository created under this section shall fully participate 16 17 in the Clerk of the Court Child Support Enforcement Collection 18 System and transmit data in a readable format as required by the contract between the Florida Association of Court Clerks 19 20 and the department.

- 2. No later than December 31, 1996, Moneys to be remitted to the department by the depository shall be done daily by electronic funds transfer and calculated as follows:
- a. For each support payment of less than \$33, 18.75 cents.
- b. For each support payment between \$33 and \$140, an amount equal to 18.75 percent of the fee charged.
- c. For each support payment in excess of \$140, 18.75 cents.
