I. <u>SUMMARY:</u>

This legislation re-creates the Mobile Home and Recreational Vehicle Protection Trust Fund, FLAIR number 76-2-463, without modification, effective upon becoming a law. The Mobile Home and Recreational Vehicle Protection Trust Fund is administered by the Department of Highway Safety and Motor Vehicles.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

The Mobile Home and Recreational Vehicle Protection Trust Fund was created by section 320.781(1), F.S.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The receipts of the Mobile Home and Recreational Vehicle Protection Trust Fund are additional fees assessed on new mobile homes and recreational vehicle title transactions and renewal fees assessed on manufacturer licenses.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary funding source for the Mobile Home and Recreational Vehicle Protection Trust Fund is mobile home license fees. Total receipts in the 2000-2001 fiscal year were \$95,004. Agency estimates for the 2001-2002 fiscal year and the 2002-2003 fiscal year are \$83,928 and \$84,768, respectively.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
