I. <u>SUMM</u>ARY:

This legislation re-creates the Working Capital Trust Fund, FLAIR #76-2-792, without modification, effective upon becoming a law. The Working Capital Trust Fund is administered by the Department of Highway Safety and Motor Vehicles.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

MAJOR STATUTES THAT CONTROL THE TRUST FUND:

The Working Capital Trust Fund was created by section 216.272, F.S.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The receipts of the Working Capital Trust Fund are expended to fund the operation of the data processing center.

For the 2001-2002 fiscal year, the Legislature appropriated \$28,930,052 from this trust fund.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary funding sources for the Working Capital Trust Fund are licenses, titles, and registration data processing services (DPS). Total receipts from these receipts in the 2000-2001 fiscal year were \$31,418,134. Agency estimates for the 2001-2002 fiscal year and the 2002-2003 fiscal year are \$25,795,368 and \$27,427,241, respectively.

Total receipts for the 2000-2001 fiscal year were \$33,312,891. Agency estimates for the 2001-2002 fiscal year and the 2002-2003 fiscal year are \$28,093,509 and \$30,291,961, respectively.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
