I. SUMMARY:

This bill provides for inclusion, into the City boundary, of naturally accreted or artificially added lands within the territory of the City of Anna Maria Island.

B. PRESENT SITUATION:

The City of Anna Maria was first chartered by chapter 9675, Laws of Florida, 1923. The charter was later abolished and rechartered as the City of Anna Maria Island by ch. 30564, Laws of Florida, 1955. That charter was abolished by ch. 59-1050, Laws of Florida. A Home Rule Charter for the City of Anna Maria was adopted by Ordinance No. 389 on January 5, 1978, and ratified at the general election on February 7, 1978.

Beach Nourishment

Beach nourishment, or the artificial addition of beach material to an area, is accomplished pursuant to provisions of ch. 161, Florida Statutes. Specifically, as part of the process, a survey is prepared and adopted by the Board of Trustees of the Internal Improvement Trust Fund. The purpose is to establish what is known as the "erosion control line" to establish a fixed boundary line between upland riparian ownership and the State's sovereign submerged ownership. While the provisions in ch. 161, F.S., provide for certain police powers to the municipality affected by the establishment of the erosion control line, those provisions do not specifically provide for the enforcement of municipal code provisions on the newly created portion of the beach.

C. EFFECT OF PROPOSED CHANGES:

This bill would extend the corporate boundary of the City of Anna Maria Island to include naturally accreted or artificially added lands within the territory of the City of Anna Maria Island.

D. SECTION-BY-SECTION ANALYSIS:

Section 1. Amends section 6 of chapter 30561 (1955), Laws of Florida, to include all artificially added or naturally accreted lands within the territory of the City of Anna Maria Island, also known as the City of Anna Maria.

Section 2. Provides that the bill is remedial and is to be liberally construed to promote its intended purpose.

Section 3. Provides for severability of the bill.

Section 4. Provides an effective date of upon becoming law.
