**I. SUMMARY:**

This bill allows the Governor to award a medal of heroism to law enforcement or corrections officers, firefighters, emergency medical technicians, or paramedics, who have distinguished themselves "conspicuously by gallantry and intrepidity and who risk their lives deliberately, above and beyond the call of duty," while performing their duty and engaging in perilous activities to preserve lives, with the knowledge of the great risk in those activities.

The candidates or persons seeking to nominate candidates for the award must make written application to the Governor. The Governor may refer applications to the Florida Department of Law Enforcement, the Department of Community Affairs, or to a private association for advice and recommendations regarding the applications.

This bill has a negligible fiscal impact upon state government, and no fiscal impact upon local governments.

B. PRESENT SITUATION:

**SIMILAR AWARDS IN FLORIDA**

Presently, a Medal of Valor may be given to law enforcement officers or correctional officers. Any state board, commission, department, division, bureau, or agency, or any county or municipality that employs or appoints law enforcement officers or correctional officers, may establish an award program to award a Medal of Valor to any such officer whose actions are extraordinary and expose the officer to peril beyond the call of duty.<sup>1</sup>

The Medal of Valor may include, but is not limited to, a medal authorized to be worn on the officer's uniform during formal occasions and a commendation bar to be worn on the uniform during normal duty. The amount of funds that may be expended to provide a Medal of Valor shall not exceed \$250.

Upon the death of such a law enforcement officer or correctional officer, the employer may present the Medal of Valor posthumously to the officer's closest living relative.

**ATTACK ON WORLD TRADE CENTER**

On September 11, 2001, two hijacked passenger jets crashed into the World Trade Center in New York City, killing over three thousand people. Many of those killed were policemen, firemen, and emergency service technicians. These professionals died trying to save others, and have been honored in a variety of ways.

After "911",<sup>2</sup> the Florida Police Chiefs' Association found that there was no standardized means of recognition for public safety workers performing acts of heroism. The association set forth to craft such an proposed award, modeling their proposal after the US Medal of Honor, which is awarded to any U.S. serviceman who "distinguishes himself conspicuously by gallantry and intrepidity at the risk of his life and beyond the call of duty" during an armed conflict.<sup>3</sup> This bill represents the culmination of that effort and is part of the legislative agenda of the Florida Police Chiefs Association.<sup>4</sup>

C. EFFECT OF PROPOSED CHANGES:

This bill allows the Governor to award a medal of heroism to law enforcement or corrections officers,<sup>5</sup> firefighters,<sup>6</sup> emergency medical technicians,<sup>7</sup> or paramedics,<sup>8</sup> who have distinguished themselves conspicuously by gallantry and intrepidity and who risk their lives deliberately, above and beyond the call of duty, while performing their duty and engaging in hazardous or perilous activities to preserve lives, with the knowledge that such activities might result in great personal harm to themselves.

The candidates or persons seeking to nominate candidates for the award must make written application to the Governor. The Governor may refer applications to the Florida Department of Law Enforcement, the Department of Community Affairs, or to a private association for advice and recommendations regarding the applications.
