insert:

Section 10. Subsection (6) of section 103.091, Florida Statutes, is amended to read:

103.091 Political parties.--

(6)(a)~~1~~. In addition to the members provided for in subsection (1), each county executive committee shall include all members of the Legislature who are residents of the county and members of their respective political party and who shall be known as at-large committeemen and committeewomen.

(b)~~2~~. Each state executive committee shall include, as at-large committeemen and committeewomen, all members of the United States Congress representing the State of Florida who are members of the political party, all statewide elected officials who are members of the party, and all members of the Legislature who are members of the political party.~~the~~

19 cast by state executive committeemen and committeewomen;

20 2.b. Lieutenant Governor: a number equal to 5 percent
21 of the votes cast by state executive committeemen and
22 committeewomen;

23 3.c. Each member of the United States Senate
24 representing the state: a number equal to 10 percent of the
25 votes cast by state executive committeemen and committeewomen;

26 4.d. Secretary of State: a number equal to 5 percent
27 of the votes cast by state executive committeemen and
28 committeewomen;

29 5.e. Attorney General: a number equal to 5 percent of
30 the votes cast by state executive committeemen and
31 committeewomen;

8 of such political party.
