Section 20.193, Florida Statutes, is 16 created to read: 17 20.193 Department of Children and Family Services 18 direct-support organization .--(1) As used in this section, the term "direct-support 19 20 organization" means a not-for-profit corporation incorporated 21 under chapter 617 and organized and operated to conduct 22 programs and activities; initiate developmental projects; 23 raise funds; request and receive grants, gifts, and bequests of moneys; acquire, receive, hold, invest, and administer, in 24 its own name, securities, funds, objectives of value, or other 25 26 property, real or personal; and make expenditures to or for 27 the direct or indirect benefit of the Department of Children 28 and Family Services or individual programs or projects of the 29 department. 30 The purposes and objectives of the direct-support organization must be consistent with the priority issues and 31

objectives of the department and must be in the best interest of the state.

- (3) The department may permit, without charge, the appropriate use of property and facilities of the state by the direct-support organization subject to the provisions of this section. Such use must be directly in keeping with the approved purpose of the direct-support organization.
- an annual postaudit of its financial accounts to be conducted by an independent certified public accountant. The annual audit report shall include a management letter and shall be submitted to the Auditor General and the department for review. The department and the Auditor General have the authority to require and receive from the organization or from its independent auditor any detail or supplemental data relative to the operation of the organization.

Section 2. Section 430.065, Florida Statutes, is created to read:

430.065 Department of Elderly Affairs direct-support organization.--

(1) As used in this section, the term "direct-support organization" means a not-for-profit corporation incorporated under chapter 617 and organized and operated to conduct programs and activities; initiate developmental projects; raise funds; request and receive grants, gifts, and bequests of moneys; acquire, receive, hold, invest, and administer, in its own name, securities, funds, objectives of value, or other property, real or personal; and make expenditures to or for the direct or indirect benefit of the Department of Elderly Affairs or individual programs or projects of the department.

1	(2) The purposes and objectives of the direct-support
2	organization must be consistent with the priority issues and
3	objectives of the department and must be in the best interest
4	of the state.
5	(3) The department may permit, without charge, the
6	appropriate use of property and facilities of the state by the
7	direct-support organization subject to the provisions of this
