Pursuant to the provisions of s. 19(f)(2), Art. (3) III of the State Constitution, the trust fund shall, unless terminated sooner, be terminated on July 1, 2006. Prior to its scheduled termination, the trust fund shall be reviewed as provided in s. 215.3206, Florida Statutes. Section 2. This act shall take effect July 1, 2002, if HB 1643 or similar legislation is adopted in the same legislative session or an extension thereof and becomes law. HOUSE SUMMARY Creates the Workers' Compensation Administration Trust Fund within the Department of Business and Professional Regulation. Provides for purposes and sources of funds. Provides for annual carryforward of fund balances. Provides for future review and termination or re-creation of the trust fund.
