A bill to be entitled

An act relating to the Boca Raton Airport
Authority; amending chapter 82-259, Laws of
Florida, as amended; requiring the Town of
Highland Beach, the City of Deerfield Beach,
and the City of Delray Beach each to appoint
one member, and the City of Boca Raton and the
Palm Beach County Commission each to appoint
two members to the Boca Raton Airport
Authority; providing residency requirements of
such appointees; providing terms of office;
providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsections (1), (2), (3), and (5) of section 4 of chapter 82-259, Laws of Florida, as amended by chapters 91-381 and 99-421, Laws of Florida, are amended to read:

 Section 4. Membership; terms of office; officers; quorum; meetings; removal.--

(1) The authority shall consist of seven members. The City of Boca Raton shall appoint two members. The City of Delray Beach shall appoint one member. The Town of Highland Beach shall appoint one member. The City of Deerfield Beach shall appoint one member. As a condition of eligibility for appointment and to hold office, all five members appointed by the municipalities must reside within their respective municipalities' boundaries the municipality, and two members

must reside within the Greater Boca Raton Reserve Area, as

municipal residents, three must reside east of the airport, one must reside west of the airport, and one may reside anywhere in the municipality.

- (2) The Palm Beach County Commission shall appoint two members, each of whom must reside within the Greater Boca Raton Reserve Area, as defined in chapter 67-1112, Laws of Florida. The city council shall appoint the five members who must reside within the limits of the municipality as specified in subsection (1).
- (3) The term of office for each member shall be two years. Each term shall expire on June 1 in the year of expiration of the term. The Palm Beach County Commission appointees' terms shall commence June 1, 2002. The City of Boca Raton appointees' terms shall commence June 1, 2002. The City of Delray Beach appointee's term shall commence June 1, 2003. The City of Deerfield Beach appointee's term shall commence June 1, 2003. The Town of Highland Beach appointee's term shall commence June 1, 2003. The county and Boca Raton Pilots Association members' terms shall expire in odd years and the other members' terms shall expire in even years.
- (5) A quorum shall consist of four three members., but The affirmative vote of four not less than three members shall be necessary to take any action except to adjourn.

Section 2. This act shall take effect upon becoming a law.
