Intent.--Pursuant to section 189.429, 10 Florida Statutes, this act constitutes the codification of all 11 special acts relating to the Plantation Acres Improvement District. It is the intent of the Legislature in enacting this 12 law to provide a single, comprehensive special act charter for 13 the district, including all current legislative authority 14 15 granted to the district by its several legislative enactments and any additional authority granted by this act and chapters 16 17 189 and 298, Florida Statutes, as amended from time to time. Section 2. Codification.--Chapters 67-924, 82-274, 18 19 86-355, and 99-426, Laws of Florida, relating to the Plantation Acres Improvement District, formerly the Dixie 20 Drainage District, are codified, reenacted, and amended as 21 22 provided herein. Section 3. The Plantation Acres Improvement District 23 24 is reenacted and the charter for the district is re-created and reenacted to read: 25 Section 1. Creation; charter amendments; abolishment 26 of the Dixie Drainage District .-- There is hereby created the 27 28 Plantation Acres Improvement District in Broward County, 29 Florida, which includes all of the area previously within the Dixie Drainage District. The district was created by special 30 31 act of the Legislature in 1982 and its charter may be amended

1	only by special act of the Legislature. The abolishment of the
2	Dixie Drainage District by chapter 82-274, Laws of Florida, is
3	hereby ratified and confirmed.
4	Section 2. Status; boundariesThe Plantation Acres
5	Improvement District is declared to be an independent
6	improvement district and a public corporation of the state
7	pursuant to chapter 298, Florida Statutes, and other
8	applicable general laws, as amended from time to time. The
9	district is created for the purposes of providing public
10	infrastructure, services, the assessment, levy, and collection
11	of taxes, non-ad valorem assessments, and fees, the operation
12	of district facilities and services, and all other purposes
13	stated in this act consistent with chapters 189 and 298,
14	Florida Statutes, and other applicable general laws. The
15	boundaries of the district shall be as follows:
16	
17	Beginning at the intersection of the said North
18	right-of-way of the North New River Canal and
19	the East line of said Section 12; thence due
20	North along the said East line of Section 12
21	and along the East line of said Section 1 a
22	distance of 3163.04 feet; thence North 0°03'55"

24	along the East line of said Section 36, a
25	distance of 5420.00 feet; thence North 0°04'12"
26	East along the said East line of Section 36, a

Applicability of certain provisions of 12 chapter 298, Florida Statutes, to the Plantation Acres 13 Improvement District; inconsistent laws inapplicable .-- The 14 provisions of chapter 298, Florida Statutes, and all 15 amendments thereto, now existing or hereafter enacted, are 16 17 declared to be applicable to the Plantation Acres Improvement District insofar as not inconsistent with the provisions of 18 19 this act or any subsequent special acts relating to the Plantation Acres Improvement District. Said Plantation Acres 20 21 Improvement District shall have all of the powers and authorities mentioned in or conferred by said chapter 298, 22 Florida Statutes, as it may be amended from time to time, 23 except as they may conflict with this act. 24 25 Section 4. Definitions.--Unless the context shall indicate otherwise, the following words as used in this act 26 27 shall have the following meanings: "Assessable improvements" includes without 28 (1)29 limitation any and all drainage and land reclamation works and 30 facilities, storm sewers and drains, streets, roads, or other 31 projects of the district, or that portion or portions thereof,

1 local in nature and of special benefit to the premises or lands served thereby, and any and all modifications, 2 3 improvements, and enlargements thereof. "Bond" includes "certificate," and provisions 4 (2) 5 applicable to bonds shall be equally applicable to б certificates. "Bond" includes general obligations bonds, 7 assessment bonds, refunding bonds, revenue bonds, or any 8 combination thereof, and such other obligations in the nature of bonds as are provided for in this act, as the case may be. 9 10 (3) "Board" means the board of supervisors of the 11 Plantation Acres Improvement District, or if such board shall be abolished, the board, body, or commission succeeding to the 12 principal functions thereof or to whom the powers given by 13 this act to the board shall be given by law. 14 "Cost," when used with reference to any project, 15 (4) includes, but is not limited to, the expenses of determining 16 17 the feasibility or practicability of acquisition, 18 construction, or reconstruction; the cost of surveys, 19 estimates, plans, and specifications; the cost of acquisition, construction, or reconstruction; the cost of improvements; 20 engineering, fiscal, and legal expenses and charges; the cost 21 of all labor, materials, machinery, and equipment; the cost of 22 all lands, properties, rights, easements, and franchises 23 acquired; federal, state, and local taxes and assessments; 24 financing charges; the creation of initial reserve and debt 25 service funds; working capital; interest charges incurred or 26 27 estimated to be incurred on money borrowed prior to and during construction and acquisition and for such period of time after 28 29 completion of construction or acquisition as the board may 30 determine; the cost of issuance of bonds pursuant to this act, 31 including advertisements and printing; the cost of any

1 election held pursuant to this act and all other expenses of issuance of bonds; discount, if any, on the sale or exchange 2 3 of bonds; administrative expenses; such other expenses as may be necessary or incidental to the acquisition, construction, 4 5 or reconstruction of any project or to the financing thereof, б or the development of any lands within the district; and 7 reimbursement of any public or private body, person, firm, or 8 corporation for any moneys advanced in connection with any of the foregoing items of cost. Any obligation or expense 9 incurred prior to the issuance of bonds in connection with the 10 11 acquisition, construction, or reconstruction of any project or improvements thereon, or in connection with any other 12 development of land that the board of the district shall 13 determine to be necessary or desirable in carrying out the 14 purposes of this act, may be treated as a part of such cost. 15 "District" means the Plantation Acres Improvement 16 (5) 17 District and "District Manager" means the manager of the 18 district. 19 (6) "Landowner" means the owner of the freehold estate, as appears by the deed record, including trustees, 20 21 private corporations, and owners of cooperative and condominium units; it does not include reversioners, 22 remaindermen, or mortgagees, who shall not be counted and need 23 24 not be notified of proceedings under this act. 25 "Project" means any development, improvement, (7) property, utility, facility, works, road, enterprise, service, 26 27 or convenience, now existing or hereafter undertaken or established under the provisions of this act or under chapter 28 29 298, Florida Statutes. 30 (8) "Water and flood control facilities" means any 31 canals, ditches, or other drainage facilities, reservoirs,

dams, levees, sluiceways, dredging holding basins, floodways, 1 pumping stations, or any other works, structures, or 2 3 facilities for the conservation, control, development, utilization, and disposal of water, and any purposes 4 5 appurtenant, necessary, or incidental thereto, and includes all real and personal property and any interest therein, б 7 rights, easements, and franchises of any nature relating to 8 any such water and flood control facilities or necessary or convenient for the acquisition, construction, reconstruction, 9 10 operation, or maintenance thereof. 11 Section 5. Board of supervisors; election; organization; terms of office; quorum; report and minutes .--12 (1) The board of the district shall be the governing 13 body of the district and shall be elected on a nonpartisan 14 basis by the qualified electors in the district in accordance 15 with the provisions of section 189.405, Florida Statutes, as 16 17 amended from time to time. The board shall exercise the powers granted to the district under this act and under chapters 189 18 19 and 298, Florida Statutes, as amended from time to time. The board shall consist of five members, and except as otherwise 20 21 provided herein, each member shall hold office for a term of 4 years and until his or her successor shall be chosen and shall 22 qualify. A majority of the members of the board shall be 23 residents of Broward County, and all members shall be 24 residents of Florida. All members of the board shall be 25 landowners within the district. 26 27 (2) Each supervisor, before entering upon his or her official duties, shall take and subscribe to an oath of office 28 as prescribed in section 298.13, Florida Statutes. 29 30 (3) All supervisors shall hold office for the terms 31 for which they are elected or appointed and until their 9

1 successors shall be chosen and qualify. In case of a vacancy in the office of any supervisor, the remaining supervisor or 2 3 supervisors (even though less than a quorum) may fill such vacancy by appointment of a new supervisor or supervisors for 4 5 the unexpired term of the supervisor who vacated his or her б office. 7 (4) As soon as practicable after each election, the 8 board shall organize by choosing one supervisor to be chair 9 and one to be vice chair of the board and by appointing a 10 recording secretary, who need not be a member of the board. In 11 the event an employee of the district serves as the board's recording secretary, an appointment to such office shall not 12 be necessary following an election. 13 (5) A majority of the members of the board shall 14 15 constitute a quorum. The board shall keep a permanent record book 16 (6) 17 entitled "Record of Proceedings of Plantation Acres Improvement District, " in which shall be recorded minutes of 18 19 all meetings, resolutions, proceedings, certificates, bonds given by all employees, and any and all corporate acts, which 20 21 book shall at reasonable times be opened to the inspection of any landowner, taxpayer, resident, or bondholder of the 22 district, and such other persons in accordance with chapter 23 24 119, Florida Statutes. Such record book shall be kept at any 25 office or other regular place of business maintained by the board in Broward County. 26 27 Section 6. Appointment and duties of district manager. -- For the purpose of preserving and maintaining any 28 29 facility constructed or erected under the provisions of this 30 act or under the provisions of chapter 298, Florida Statutes, 31 and for maintaining and operating the equipment owned by the

district and such other duties as may be prescribed by the 1 board, the board may employ and fix the compensation of a 2 3 district manager who shall have charge and supervision of the works of the district. 4 5 Section 7. Treasurer; depositories; fiscal agent .-б (1) The board shall designate a person who is a 7 resident of Florida, or a bank or trust company organized 8 under the laws of Florida or under the National Banking Act, as treasurer of the district, who shall have charge of the 9 funds of the district. Such funds shall be disbursed only upon 10 11 the order of, or pursuant to, the resolution of the board by warrant or check signed by the treasurer, or by such other 12 person as may be authorized by the board. The board may give 13 the treasurer such other or additional powers and duties as 14 the board may deem appropriate, and fix his or her 15 compensation. The board may require the treasurer to give a 16 bond in such amount, on such terms, and with such sureties as 17 may be deemed satisfactory to the board to secure the 18 19 performance by the treasurer of his or her powers and duties. The board shall audit or have audited the books of the 20 treasurer at least once a year. 21 The board shall select depositories in which the 22 (2) bonds and funds of the board and of the district shall be 23 24 deposited in accordance with chapter 280, Florida Statutes, 25 governing public deposits. Section 8. Compensation of board.--Each supervisor 26 27 shall be entitled to receive for his or her services an amount not to exceed \$300 per month. In addition, each supervisor 28 29 shall receive reasonable traveling expenses for attending district business outside of the district. Unless the board by 30 resolution otherwise provides, such traveling expenses shall 31

1 not be in excess of the amounts provided by law for state and 2 county officials. 3 Section 9. Powers. -- The district shall have, and the board may exercise, any or all of the following powers: 4 5 To contract and be contracted with; to sue and be (1) б sued in the name of the district; to adopt and use a seal; and 7 to acquire by purchase, gift, devise, eminent domain, (except as limited herein), or otherwise, property, real or personal, 8 or any estate therein, within the district, to be used for any 9 10 of the purposes of this act. 11 (2) To adopt a water control plan; and to establish, construct, operate, and maintain a system of main and lateral 12 canals, drains, ditches, levees, dikes, dams, sluices, locks, 13 revetments, reservoirs, holding basins, floodways, pumping 14 stations, syphons, culverts, and storm sewers to drain and 15 reclaim the lands within the district and to connect some or 16 17 any of them with roads and bridges as in the judgment of the board is deemed advisable to provide access to such 18 19 facilities. (3) To acquire and maintain appropriate sites for 20 storage and maintenance of the equipment of the district; and 21 to acquire and maintain and construct a suitable building to 22 house the office and records of the district. 23 24 (4) To clean out, straighten, widen, open up or change 25 the course and flow of, alter, or deepen any canal, ditch, drain, river, water course, or natural stream as within the 26 27 judgment of the board is deemed advisable to drain and reclaim 28 the lands within the district; to acquire, purchase, operate 29 and maintain pumps, plants, and pumping systems for drainage 30 purposes; and to construct, operate, and maintain irrigation 31

1 works and machinery in connection with the purposes herein set 2 forth. 3 (5) To regulate and set forth by appropriate resolution the drainage requirements and conditions to be met 4 5 for any development upon any land within the district, б including, but not limited to, authority to require as a condition precedent for any development that good and 7 8 sufficient bond be posted to ensure proper drainage for the area to be developed. 9 10 (6) To borrow money and issue bonds, certificates, 11 warrants, notes, or other evidences of indebtedness of the district as hereinafter provided. 12 (7) To build and construct any other works and 13 improvements deemed necessary to preserve and maintain the 14 works in or out of the district; to acquire, construct, 15 operate, maintain, use, sell, convey, transfer, or otherwise 16 17 provide for machines and equipment for any purpose authorized by this act or chapter 298, Florida Statutes; and to contract 18 19 for the purchase, construction, operation, maintenance, use, sale, conveyance, and transfer of the said machinery and 20 equipment. 21 22 (8) To construct or enlarge, or cause to be constructed or enlarged, any and all bridges or culverts that 23 24 may be needed in or out of the district, across any drain, ditch, canal, floodway, holding basin, excavation, public 25 highway, tract, grade, fill, or cut; to construct roadways 26 27 over levees and embankments; and to construct any and all of 28 said works and improvements across, through, or over any 29 public right-of-way, highway, grade, fill, or cut in or out of 30 the district.

1 (9) To hold, control, and acquire by donation, purchase, or condemnation, any easement, reservation, or 2 3 dedication in the district, for any of the purposes herein provided; and to condemn as provided by chapters 73 and 74, 4 5 Florida Statutes, or acquire by purchase or grant for use in б the district, any land or property within the district 7 necessary for the purpose of this act. 8 (10) To assess and impose upon all of the lands in the 9 district an ad valorem tax, an annual improvement tax, and a 10 maintenance tax as hereinafter provided. 11 (11) To impose and foreclose special assessment liens as hereinafter provided. 12 (12) To prohibit, regulate, and restrict by 13 appropriate resolution all structures, materials, and things, 14 whether solid, liquid, or gas, whether permanent or temporary 15 in nature, which come upon, come into, connect to, or be a 16 17 part of any facility owned or operated by the district. 18 (13) To administer and provide for the enforcement of 19 all of the provisions herein, including the making, adopting, promulgating, amending, and repealing of all regulations 20 21 necessary or convenient for the carrying out of the duties, obligations, and powers conferred on the district created 22 hereby. 23 24 (14) To cooperate with or contract with other 25 governmental agencies as may be necessary, convenient, 26 incidental, or proper in connection with any of the powers, 27 duties, or purposes of the district as stated in this act. (15) To employ engineers, attorneys, consultants, 28 29 agents, employees, and representatives as the board of 30 supervisors may from time to time determine necessary and to 31 fix their compensation and duties.

1 (16) To exercise all of the powers necessary, convenient, incidental, or proper in connection with any of 2 3 the powers, duties, or purposes of said district as stated in 4 this act. 5 (17) To construct, improve, and maintain roadways and б roads necessary and convenient to provide access to, and 7 efficient development of, areas made suitable and available 8 for cultivation, development, settlement, urban subdivision, homesites, and other beneficial developments as a result of 9 10 the drainage operations of the district. 11 (18) To make use of any public easements, dedications to public use, platted reservations for public purposes, or 12 any reservations for roadway or drainage purposes within the 13 14 boundaries of the district. (19) To lease as lessor or lessee to or from any 15 person, firm, corporation, association, or body, public or 16 private, any projects of the type that the district is 17 18 authorized to undertake and facilities or property of any 19 nature for the use of the district to carry out any of the purposes of this act. 20 (20) To regulate the supply and level of water within 21 the district; to divert waters from one area, lake, pond, 22 river, stream, basin, or drainage or water flood control 23 facility to any other area, lake, pond, river, stream, basin, 24 or drainage and water flood control facility; to regulate, 25 control, and restrict the development and use of natural or 26 27 artificial streams or bodies of water, lakes, or ponds; and to 28 take all measures determined by the board to be necessary or 29 desirable to prevent or alleviate land erosion or flooding. 30 The powers granted to the district by this subsection shall be concurrent, within the boundaries of the district, with other 31

1 public bodies, agencies, or authorities as may be authorized by law. The district is eligible to receive moneys, 2 3 disbursements, and assistance from the state available to 4 flood control or water management districts and the navigation 5 districts or agencies. б (21) To issue general obligation bonds, revenue bonds, 7 assessment bonds, or any other bonds or obligations authorized 8 by the provisions of this act or any other law, or any 9 combination of the foregoing, to pay all or part of the cost of the acquisition, construction, reconstruction, extension, 10 11 repair, improvement, maintenance, or operation of any project or combination of projects, to provide for any facility, 12 service, or other activity of the district, and to provide for 13 the retirement or refunding of any bonds or obligations of the 14 district, or for any combination of the foregoing purposes. 15 (22) To establish administrative and financial "units" 16 17 within the district, as described and governed by section 298.353, Florida Statutes, as it may be amended from time to 18 19 time. (23) To exercise any and all other powers conferred 20 21 upon water control districts by chapter 298, Florida Statutes. 22 Section 10. Seal.--The official seal of the district shall bear the legend "Plantation Acres Improvement District, 23 Broward County, Florida, Seal, Established 1982." 24 25 Section 11. Fiscal year. -- The board by resolution shall establish the fiscal year for the district. 26 27 Section 12. Annual budget. -- Prior to June 1 of each year after this act is effective, the treasurer of the 28 29 district shall prepare a proposed budget to be submitted to 30 the board for its approval. The proposed budget shall include 31 an estimate of all necessary expenditures of the district for

1 the next ensuing fiscal year and an estimate of income to the district from the taxes and assessments provided in this act. 2 3 The board shall consider the proposed budget item by item and may either approve the budget as proposed by the district 4 5 manager or modify the same in part or in whole. The board б shall indicate its approval of the budget by resolution, which 7 resolution shall provide for a hearing on the budget as 8 approved. Notice of the hearing on the budget shall be published in a newspaper in general circulation within the 9 district in Broward County, Florida, once a week for 2 10 11 consecutive weeks, provided that the second publication shall not be less than 7 days after the first publication. The 12 notice shall be directed to all landowners in the district and 13 shall state the purpose of the meetings. The notice shall 14 further contain a designation of the date, time, and place of 15 the public hearing, which shall be not less than 7 days after 16 17 the second publication. At the time and place designated in the notice, the board shall hear all objections to the budget 18 19 as proposed, and make such changes as the board deems necessary. At the conclusion of the budget hearing, the board 20 shall, by resolution, adopt the budget as finally approved by 21 22 the board. Section 13. Plan of improvement of roads and water 23 control; proceedings thereof. -- The board may proceed to adopt 24 25 a water control plan as provided in chapter 298, Florida Statutes, or as provided in this section. The board shall 26 27 cause to be made by the chief engineer, or such other engineer 28 or engineers as the board may employ for that purpose, a 29 complete and comprehensive plan for water control of the lands 30 or improvements of roads located within the district which 31

1 meets the requirements of sections 298.225 and 298.301, Florida Statutes, as amended from time to time. 2 3 Section 14. Amendment of water control plan.--The board may at any time and from time to time amend its water 4 5 control plan or any plan providing for the construction of б roads upon or the drainage of lands within the district in 7 accordance with the procedures established in chapter 298, Florida Statutes, and may provide for such new and additional 8 drainage facilities, canals, ditches, levees, roads, and other 9 works as the board may determine. In connection with the 10 11 revision of any water control plan or the provision of any new or additional road or drainage facilities, canals, ditches, 12 levees, or other works, or in the event the total taxes and 13 assessments theretofore levied or the funds derived from the 14 sale of bonds are insufficient to pay the cost of any drainage 15 works, benefits may be reassessed, additional assessments 16 17 made, and taxes levied in accordance with the procedures provided in this act or in chapter 298, Florida Statutes. The 18 19 board may at any time approve and make effective technical changes or modifications in any plan of improvement or 20 reclamation not affecting assessed benefits, levy of taxes, or 21 the security of bondholders. 22 Section 15. Assessing land for development; 23 24 apportionment of assessment. -- After the requirements of chapter 298, Florida Statutes, have been met regarding the 25 water control plan, engineer's report, and list of lands with 26 27 assessed benefits, the district shall levy a non-ad valorem assessment or special assessment in accordance with chapter 28 29 298, Florida Statutes, as amended from time to time, and this 30 act. 31

1	Section 16. Prepayment of taxes or assessmentsThe
2	board may provide that any tax or assessment may be paid at
3	any time before due, together with interest accrued thereon to
4	the date of prepayment and any prepayment premiums or
5	penalties, if such prior payment shall be permitted by the
6	proceedings authorizing any bonds or other obligations for the
7	payment of which special assessments have been pledged or
8	taxes levied.
9	Section 17. Tax liensAll taxes and non-ad valorem
10	assessments of the district provided for in this act or
11	chapter 298, Florida Statutes, together with all penalties for
12	default in the payment of the same and all costs in collecting
13	the same, shall constitute a lien as provided in chapter 298,
14	Florida Statutes, as amended from time to time. A sale of any
15	of the real property within the district for state and county
16	or other taxes shall not operate to relieve or release the
17	property so sold from the lien for subsequent district taxes
18	or installments of district taxes which lien may be enforced
19	against such property as though no such sale thereof had been
20	made. The provisions of section 194.171, Florida Statutes, and
21	amendments thereto, shall be applicable to district taxes with
22	the same force and effect as if said provisions were expressly
23	set forth in this act.
24	Section 18. Issuance of bond anticipation notesIn
25	addition to the other powers provided for in this act and not
26	in limitation thereof, the district shall have the power, at
27	any time and from time to time, after the authorization to
28	issue any bonds of the district, to borrow money for the
29	purposes for which such bonds are to be issued and in
30	anticipation of the receipt of the proceeds of the sale of
31	such bonds. Such bond anticipation notice may be issued, at

1	any time and from time to time, to issue bond anticipation
2	notes in a principal sum not in excess of the authorized
3	maximum amount of such bond issue. Such notes shall be in such
4	denomination or denominations, bear interest at such rate as

7	from the date of issuance, and be in such form and executed in
8	such manner as the board shall prescribe. Such notes may be

18	Section 19. Short term borrowingThe district at any
19	time may obtain loans, in such amount and on such terms and
20	conditions as the board may approve, for the purpose of paying
21	any of the expenses of the district or any costs incurred or
22	that may be incurred in connection with any of the projects of
23	the district, which loans shall have a term not exceeding 2
24	years from the date of issuance and may be renewable for a
25	like term or terms and shall bear such interest as the board
26	may determine, not to exceed the highest rate allowed by law,
27	and may be payable from and secured by a pledge of such funds,
28	revenues, taxes, and assessments as the board may determine.
29	For the purpose of defraying such costs and expenses, the
30	district may issue negotiable notes, warrants, or other
31	evidences of debt signed on behalf of the district by any one

1 of the board duly authorized by the board, such notes or other evidences of indebtedness to be payable at such times, to bear 2 3 such interest as the board may determine not to exceed the highest rate allowed by general law per annum, and to be sold 4 5 or discounted at such price or prices and on such terms as the б board may deem advisable. The board shall have the right to 7 provide for the payment thereof by pledging the whole or any 8 part of the funds, revenues, taxes, and assessments of the district. The approval of the qualified electors who are 9 10 freeholders residing in the district shall not be necessary 11 except where required by Florida law. Section 20. Trust agreements. -- In the discretion of 12 the board, any issue of bonds may be secured by a trust 13 agreement by and between the district and a corporate trustee 14 or trustees, which may be any trust company or bank having the 15 powers of a trust company within or without the state. The 16 17 resolution authorizing the issuance of the bonds or such trust 18 agreement may pledge the revenues to be received from any 19 projects of the district and may contain such provisions for protecting and enforcing the rights and remedies of the 20 bondholders as the board may approve, including without 21 limitation covenants setting forth the duties of the district 22 in relation to the acquisition, construction, reconstruction, 23 improvement, maintenance, repair, operation, and insurance of 24 any projects, the fixing and revising of the rates, fees, and 25 charges, and the custody, safeguarding, and application of all 26 27 moneys, and for the employment of consulting engineers in connection with such acquisition, construction, 28 29 reconstruction, improvement, maintenance, repair, or 30 operation. It shall be lawful for any bank or trust company 31 incorporated under the laws of the state, which may act as a

1 depository of the proceeds of bonds or of revenues, to furnish such indemnifying bonds or to pledge such securities as may be 2 3 required by the district. Such resolution or trust agreement may set forth the rights and remedies of the bondholders and 4 5 of the trustee, if any, and may restrict the individual right б of action by bondholders. Sale of bonds.--Bonds may be sold in 15 blocks or installments at different times, or an entire issue 16 17 or series may be sold at one time. Bonds may be sold at public or private sale after such advertisement, if any, as the board 18 19 may deem advisable, but not in any event at less than 95 percent of the par value thereof, together with accrued 20 interest thereon. Bonds may be sold or exchanged for refunding 21 bonds. Special assessment and revenue bonds may be delivered 22 as payment by the district of the purchase price or lease of 23 any project or part thereof, or a combination of projects or 24 25 parts thereof, or as the purchase price or exchanged for any property, real, personal, or mixed, including franchises, or 26 27 services rendered by any contractor, engineer, or other person, all at one time or in blocks from time to time, in 28 29 such manner and upon such terms as the board in its discretion 30 shall determine. The price or prices for any bonds sold, 31 exchanged, or delivered may be:

1 (1) The money paid for the bonds. The principal amount, plus accrued interest to the 2 (2) 3 date of redemption or exchange, or outstanding obligations exchanged for refunding bonds. 4 5 In the case of special assessment or revenue (3) б bonds, the amount of any indebtedness to contractors or other 7 persons paid with such bonds, or the fair value of any 8 properties exchanged for the bonds, as determined by the 9 board. 10 Section 22. Authorization and form of bonds.--Bonds 11 may be authorized by resolution or resolutions of the board which shall be adopted by a majority of all of the members 12 thereof then in office. Such resolution or resolutions may be 13 adopted at the same meeting at which they are introduced, and 14 need not be published or posted. The board may by resolution 15 authorize the issuance of bonds and fix the aggregate amount 16 17 of bonds to be issued, the purpose or purposes for which the moneys derived therefrom shall be expended, the rate or rates 18 19 of interest, not to exceed the highest rate allowed by law, the denomination of the bonds, whether or not the bonds are to 20 21 be issued in one or more series, the date or dates of maturity, which shall not exceed 40 years from their 22 respective dates of issuance, the medium of payment, the place 23 24 or places within or without the state where payment shall be made, registration privileges, redemption terms and privileges 25 (whether with or without premium), the manner of execution, 26 27 the form of the bonds including any interest coupons to be attached thereto, the manner of execution of bonds and 28 29 coupons, and any and all other terms, covenants, and 30 conditions thereof, and the establishment of revenue or other 31 funds. Such authorizing resolution may further provide that

1 such bonds may be executed manually or by engraved, lithographed, or facsimile signature, provided that where 2 3 signatures are engraved, lithographed, or facsimile, no bond shall be valid unless countersigned by a registrar or other 4 5 officer designated by appropriate resolution of the board. The б seal of the district may be affixed, lithographed, engraved, or facsimile on such bonds. In case any officer whose 7 8 signature shall appear on any bonds or coupons shall cease to be such officer before the delivery of such bonds, such 9 10 signature or facsimile shall nevertheless be valid and 11 sufficient for all purposes the same as if he or she had remained in office until such delivery. 12 Section 23. Interim certificates; replacement 13 certificates. -- Pending the preparation of definitive bonds, 14 the board may issue interim certificates or receipts or 15 temporary bonds, in such form and with such provisions as the 16 board may determine, exchangeable for definitive bonds when 17 such bonds shall have been executed and are available for 18 19 delivery. The board may also provide for the replacement of any bonds which shall become mutilated or shall be lost or 20 destroyed. 21 Section 24. Negotiability of bonds. -- Any bond issued 22 under this act and any interim certificate, receipt, or 23 24 temporary bond, in the absence of an express recital on the face thereof that it is nonnegotiable, shall be fully 25 negotiable and shall be and constitute negotiable instruments 26 27 within the meaning and for all purposes of the law merchant 28 and the laws of Florida. 29 Section 25. Defeasance. -- The board may make such 30 provision with respect to the defeasance of the right, title, 31 and interest of the holders of any of the bonds and

1 obligations of the district in any revenues, funds, or other properties by which such bonds are secured as the board deems 2 3 appropriate and, without limitation on the foregoing, may provide that when such bonds or obligations become due and 4 5 payable or shall have been called for redemption, and the б whole amount of the principal and interest and premium, if 7 any, due and payable upon the bonds or obligations then 8 outstanding shall be paid, or sufficient moneys or direct 9 obligations of the United States Government the principal of and the interest on which when due will provide sufficient 10 11 moneys, shall be held or deposited in trust for such purpose, and provision shall also be made for paying all other sums 12 payable in connection with such bonds or other obligations, 13 then and in such event the right, title, and interest of the 14 holders of the bonds in any revenues, funds, or other 15 properties by which such bonds are secured shall thereupon 16 17 cease, determine, and become void, and the board may apply any surplus in any sinking fund established in connection with 18 19 such bonds or obligations and all balances remaining in all other funds or accounts other than money held for the 20 redemption or payment of the bonds or other obligations to a 21 lawful purpose of the district as the board shall determine. 22 Section 26. Issuance of additional bonds.--If the 23 24 proceeds of any bonds shall be less than the cost of 25 completing the project in connection with which such bonds are issued, the board may authorize the issuance of additional 26 27 bonds, upon such terms and conditions as the board may provide in the resolution authorizing the issuance thereof, but only 28 29 in compliance with the resolution or other proceedings 30 authorizing the issuance of the original bonds. 31

1	Section 27. Refunding bondsThe district shall have
2	the power to issue bonds to provide for the retirement or
3	refunding of any bonds or obligations of the district that at
4	the time of such issuance are or subsequently thereto become
5	due and payable, or that at the time of issuance have been
6	called or are or will be subject to call for redemption within
7	10 years thereafter, or the surrender of which can be procured
8	from the holders thereof at prices satisfactory to the board.
9	Refunding bonds may be issued at any time when in the judgment
10	of the board such issuance will be advantageous to the
11	district. No approval of the qualified electors who are
12	freeholders residing in the district shall be required for the
13	issuance of refunding bonds except in cases where such
14	approval is required by the constitution. The board may by
15	resolution confer upon the holders of such refunding bonds all

27	Section 28. Revenue bonds
28	(1) The district shall have the power to issue revenue
29	bonds from time to time without limitation as to amount. Such
30	revenue bonds may be secured by or payable from the gross or
31	net pledge of the revenues to be derived from any project or

1 combination of projects, from the rates, fees, or other charges to be collected from the users of any project or 2 3 projects, from any revenue-producing undertaking or activity of the district, or from any other source or pledged security. 4 5 Such bonds shall not constitute an indebtedness of the district, and the approval neither of the qualified electors б 7 nor of the qualified electors who are freeholders shall be 8 required unless such bonds are additionally secured by the full faith and credit and taxing power of the district in 9 10 which case approval of the qualified electors who are 11 freeholders shall be required. (2) Any two or more projects may be combined and 12 consolidated into a single project, and may thereafter be 13 operated and maintained as a single project. The revenue bonds 14 authorized herein may be issued to finance any one or more of 15 such projects regardless whether or not such projects have 16 17 been combined and consolidated into a single project. If the board deems it advisable, the proceedings authorizing such 18 19 revenue bonds may provide that the district may thereafter combine the projects then being financed or theretofore 20 financed with other projects to be subsequently financed by 21 the district, and that revenue bonds to be thereafter issued 22 by the district shall be on parity with the revenue bonds then 23 being issued, all on such terms, conditions, and limitations 24 as shall be provided, and may further provide that the 25 revenues to be derived from the subsequent projects shall at 26 27 the time of the issuance of such parity revenue bonds be also pledged to the holders of any revenue bonds theretofore issued 28 29 to finance the revenue undertakings which are later combined 30 with such subsequent projects. The district may pledge for the 31

1 security of the revenue bonds a fixed amount, without regard to any fixed proportion of the gross revenues of any project. 2 3 Section 29. General obligation bonds .--(1) The district shall have the power from time to 4 5 time to issue general obligation bonds in an aggregate б principal amount of bonds outstanding at any one time not in 7 excess of 35 percent of the assessed value of the taxable 8 property within the district as shown on the pertinent tax records at the time of the authorization of the general 9 obligation bonds for which the full faith and credit of the 10 11 district is pledged. Except for refunding bonds, no general obligation bonds shall be issued unless the issuance thereof 12 shall have been approved at an election of the qualified 13 electors, which shall be called and held in accordance with 14 the requirements for such election as prescribed by the 15 constitution and election laws of Florida. Such elections 16 17 shall be called to be held in the district by the Board of County Commissioners of Broward County upon the request of the 18 19 board of the district. The expenses of calling and holding such referendum elections shall be borne by the district and 20 the district shall reimburse the county for any expenses 21 incurred in calling or holding such elections. In the 22 alternative, at the option of the board, the board may make 23 24 such other provision for the registration of such qualified 25 electors and the calling and holding of such elections as the board may from time to time deem appropriate. 26 27 The district may pledge its full faith and credit (2) for the payment of the principal and interest on such general 28 29 obligation bonds, and for any reserve or other funds provided 30 therefor, and may unconditionally and irrevocably pledge 31 itself to levy ad valorem taxes on all taxable property in the

1 district, to the extent necessary for the payment thereof, without limitations as to rate or amount. 2 3 (3) If the board shall determine to issue general 4 obligation bonds for more than one different purpose, the 5 approval of the issuance of the bonds for each and all such б purposes may be submitted to the electors on one and the same ballot. The failure of the electors to approve the issuance of 7 8 bonds for any one or more purposes shall not defeat any 9 approval of bonds for any other purpose. 10 Section 30. Bonds as legal investment or 11 security .-- Notwithstanding any provisions of any other law to the contrary, all bonds issued under the provisions of this 12 act shall constitute legal investment for savings banks, 13 banks, trust companies, insurance companies, executors, 14 administrators, trustee guardians, and other fiduciaries, and 15 for any board, body, agency, instrumentality, county, 16 17 municipality, or other political subdivision of the state, and shall be and constitute securities which may be deposited by 18 19 banks or trust companies as security for deposits of state, county, municipal, or other public funds, by insurance 20 21 companies as required or voluntary statutory deposits. 22 Section 31. Covenants. -- Any resolution authorizing the issuance of bonds may contain such covenants as the board may 23 24 deem advisable and all such covenants shall constitute valid and legally binding and enforceable contracts between the 25 district and the bondholders, regardless of the time of 26 27 issuance thereof. Such covenants may include, without limitation, covenants concerning the disposition of the bond 28 29 proceeds, the use and disposition of project revenues, the 30 pledging of revenues, taxes, and assessments, the obligation of the district with respect to the operation of the project 31

1	and the maintenance of adequate project revenues, the issuance
2	of additional bonds, the appointment powers and duties of
3	trustees and receivers, the acquisition of outstanding bonds
4	and obligations, restrictions on the establishing of competing
5	projects or facilities, restrictions on the sale or disposal
б	of the assets and property of the district, the priority of
7	assessment liens, the priority of claims by bondholders on the
8	taxing power of the district, the maintenance of deposits to
9	ensure the payment of revenues by users of district facilities
10	or services, the discontinuance of district services by reason
11	of delinquent payments, acceleration upon default, the
12	execution of necessary instruments, the procedure for amending
13	or abrogating covenants with the bondholders, and such other
14	covenants as may be deemed necessary or desirable for the
15	security of the bondholders.
16	Section 32. Validity of bonds; validation
17	proceedings
18	(1) Any bonds issued by the district shall be
19	incontestable in the hands of bona fide purchasers or holders
20	for value and shall not be invalid because of any irregularity
21	or defects in proceedings for the issue and sale thereof.
22	Prior to the issuance of any bonds, the district may, but is
23	not required to, publish notice at least once in a newspaper
24	or newspapers of general circulation in Broward County and
25	within the district stating the date of adoption of the
26	resolution authorizing such obligations, the amount, the
27	maximum rate of interest and maturity of such obligations, and
28	the purpose in general terms for which such obligations are to
29	be issued, and further stating that any action or proceeding
30	questioning the validity of such obligations or of the
31	proceedings authorizing the issuance thereof, or of any of the

1 covenants made therein, must be instituted within 20 days after the first publication of such notice, or the validity of 2 3 such obligations, proceedings, and covenants shall not be thereafter questioned in any court whatsoever. If no such 4 5 action or proceeding is so instituted within such 20-day б period, then the validity of such obligations, proceedings, 7 and covenants shall be conclusive, and all persons or parties 8 whatsoever shall be forever barred from questioning the validity of such obligations, proceedings, or covenants in any 9 10 court whatsoever. 11 (2) The power of the district to issue bonds under the provisions of this act may be determined and any of the bonds 12 of the district may be validated and confirmed by circuit 13 14 court decree under the provisions of chapter 75, Florida Statutes, and laws amendatory thereof or supplementary 15 16 thereto. 17 Section 33. Authority for issuance of bonds.--This act constitutes full and complete authority for the issuance of 18 19 bonds and the exercise of the powers of the district provided herein. No procedures or proceedings, publications, notices, 20 consents, approvals, orders, acts, or things by the board, or 21 any board, officers, commission, department, agency, or 22 instrumentality of the district, other than those required by 23 24 this act, shall be required to issue any bonds or to do any act or perform anything under this act, and the issuance or 25 sale of bonds pursuant to the provisions of this act need not 26 27 comply with the requirements of any other law applicable to the issuance or sale of bonds, except as otherwise provided in 28 29 this act, and shall not require the consent or approval of the board of drainage commissioners of the State of Florida or of 30 any other board, officers, commission, department, agency, or 31

1 instrumentality of the State of Florida or any political subdivision thereof. Except as otherwise provided herein, no 2 3 proceedings or procedures of any character whatever shall be necessary or required for the issuance of bonds other than the 4 5 adoption of an appropriate resolution by the board as provided б in this act with respect to the issuance of the same. The 7 powers conferred by this act on the district with respect to 8 the issuance and sale of bonds shall be in addition and supplemental to the powers conferred by any other law. 9 10 Section 34. Pledge by the State of Florida to the 11 bondholders of the district and to the Federal Government.--The State of Florida pledges to the holders of 12 any bonds issued under this act that it will not limit or 13 alter the rights of the district to own, acquire, construct, 14 reconstruct, improve, maintain, operate, or furnish the 15 projects or to levy and collect the taxes, assessments, 16 17 rentals, rates, fees, and other charges provided for herein and to fulfill the terms of any agreement made with the 18 19 holders of such bonds or other obligations, and that it will not in any way impair the right or remedies of the holders. 20 Section 35. Ad valorem taxes.--The board shall have 21 the power to levy and assess an ad valorem tax on all the 22 taxable property in the district to pay the principal of and 23 24 interest on any general obligation bonds of the district, or to provide for any sinking or other funds established in 25 connection with any such bonds, or both. The ad valorem tax 26 27 provided for herein shall not exceed 2 mills and shall be in addition to the county and all other ad valorem taxes provided 28 29 for by law. Such tax shall be assessed, levied, and collected 30 in the same manner and same time as county taxes. The tax 31

1 shall be a lien until paid on the property against which assessed, enforceable in like manner as county tax liens. 2 3 Section 36. Annual installment taxes.--The board may levy and collect annual installment taxes. Such taxes shall be 4 5 levied in accordance with chapter 298, Florida Statutes, as б amended from time to time. 7 Section 37. Maintenance tax.--The board may levy an 8 annual maintenance tax. Such tax shall be levied in accordance 9 with chapter 298, Florida Statutes, as amended from time to 10 time. 11 Section 38. Enforcement of taxes.--The collection and enforcement of all assessments or taxes levied by the district 12 shall be as provided in chapter 298, Florida Statutes, as 13 amended from time to time. 14 Section 39. When unpaid tax is delinguent; 15 penalty.--All taxes provided for in this act shall become 16 delinquent and bear penalties in accordance with chapter 298, 17 Florida Statutes, as amended from time to time. 18 19 Section 40. Tax exemption. -- As the exercise of the powers conferred by this act constitute the performance of 20 21 essential public functions, and as the projects of the district will constitute public property used for public 22 purposes, all assets and properties of the district, and all 23 24 bonds issued hereunder and interest paid thereon, and all fees, charges, and other revenues derived by the district from 25 the projects provided by this act shall be exempt from all 26 27 taxes by the state or by any political subdivision, agency, or instrumentality thereof. However, nothing in this act shall be 28 29 deemed to exempt from taxation any property, project, 30 facility, or business activity or enterprise that cannot 31 validly be undertaken as a public function by special taxing

1 districts or other public bodies under the laws and Constitution of Florida and, further, that nothing in this act 2 3 shall be deemed to exempt any property, project, facility, or business activity or enterprise of the district, or revenues 4 5 derived therefrom, which would be subject to taxation under б the general laws of Florida if such property, project, or 7 facility were owned or undertaken by a municipal corporation. 8 Section 41. Non-ad valorem or special 9 assessments. -- The board shall levy non-ad valorem or special 10 assessments in accordance with this section or chapter 189, 11 chapter 197, or chapter 298, Florida Statutes: (1) AUTHORITY FOR PROVIDING IMPROVEMENTS AND LEVYING 12 AND COLLECTING SPECIAL ASSESSMENTS AGAINST PROPERTY 13 BENEFITED. -- The board may provide for the construction, 14 reconstruction, repair, paving, repaving, hard surfacing, 15 rehard surfacing, widening, guttering, and drainage of 16 17 streets; may provide for the drainage and reclamation of wet, low, or overflowed lands; and may provide for the payment of 18 19 all or any part of the costs of any such improvements by levying and collecting special assessments on the abutting, 20 21 adjoining, contiguous, or other specifically benefited 22 property. 23 (2) METHOD OF PRORATING SPECIAL ASSESSMENTS.--Special 24 assessments against property deemed to be benefited by local improvements, as provided for in section 42(1), shall be 25 assessed upon the property specially benefited by the 26 27 improvement in proportion to the benefits to be derived therefrom, said special benefits to be determined and prorated 28 29 according to such method as the board may prescribe. 30 (3) RESOLUTION REQUIRED TO DECLARE SPECIAL 31 ASSESSMENTS. -- When the board may determine to make any

1 assessable improvement and defray the whole or any part of the expense thereof by special assessments, the board shall so 2 3 declare by resolution stating the nature of the proposed improvement, designating the street or streets to be improved, 4 5 the location of storm sewers and drains, or the location of the drainage project, and the part or portion of the expense б 7 thereof to be paid by special assessments, the manner in which 8 said assessments shall be made, when said assessments are to be paid, and what part, if any, shall be apportioned to be 9 10 paid from the general improvement fund of the board; and said 11 resolution shall also designate the lands upon which the special assessments shall be levied and, in describing said 12 lands, it shall be sufficient to describe them as "all lots 13 and lands adjoining and contiguous or bounding and abutting 14 upon such improvements or specially benefited thereby and 15 further designated by the assessment plat hereinafter provided 16 17 for." Such resolution shall also state the total estimated cost of the improvement. Such estimated cost shall include the 18 19 cost of construction or reconstruction, the cost of all labor and materials, the cost of all lands, property, rights, 20 easements, and franchises acquired, financing charges, 21 interest prior to and during construction and for 1 year after 22 completion of construction, discount on the sale of special 23 24 assessment bonds, cost of plans and specifications, inspections, surveys of estimates of costs and of revenues, 25 cost of engineering and legal services, printing and 26 27 publishing notices and proceedings, abstracting title, and all 28 other expenses necessary or incident to determining the 29 feasibility or practicability of such construction or 30 reconstruction, administrative expense, and such other expense 31

1 as may be necessary or incident to the financing herein 2 authorized. 3 (4) PLANS AND SPECIFICATIONS, WITH ESTIMATED COST OF 4 PROPOSED IMPROVEMENT REQUIRED BEFORE ADOPTION OF 5 RESOLUTION. -- At the time of the adoption of the resolution б provided for in subsection (3), there shall be on file with 7 the secretary of the board an assessment plat showing the area 8 to be assessed, with plans and specifications, and an estimate of the apportioned cost and benefit to each lot of the 9 10 proposed improvement, which assessment plat, plans and 11 specifications, and estimate shall be open to the inspection 12 of the public. (5) PUBLICATION OF RESOLUTION. -- Upon the adoption of 13 the resolution provided for in subsection (3), the board shall 14 cause said resolution to be published one time in a newspaper 15 of general circulation published in the district, and shall 16 17 cause said resolution to be published once a week for a period of 2 weeks in a newspaper of general circulation published in 18 19 Broward County. (6) ASSESSMENT ROLL.--Upon the adoption of the 20 resolution aforesaid, the board shall cause to be made an 21 assessment roll in accordance with the method of assessment 22 provided for in said resolution, which assessment roll shall 23 24 be completed and filed with the secretary of the board as 25 promptly as possible. Said assessment roll shall show the lots and lands assessed and the amount of the benefit to and the 26 27 assessment against each lot or parcel of land. If said 28 assessment is to be paid in installments, the number of annual 29 installments in which the assessment is divided shall also be 30 entered and shown upon said assessment roll. 31

1	(7) PUBLICATION OF ASSESSMENT ROLLUpon the
2	completion of said assessment roll, the board shall by
3	resolution fix a time and place at which the owners of the
4	property to be assessed, or any other persons interested
5	therein, may appear and be heard as to the propriety and
6	advisability of making such improvements, as to the cost
7	thereof, as to the manner of payment therefor, and as to the
8	amount thereof to be assessed against each property so
9	improved. Ten days' notice in writing of such time and place
10	shall be given to such property owners which shall be served
11	by mailing a copy of such notice to each of such property
12	owners at his or her last known address, the names and
13	addresses of such property owners to be obtained from the
14	records of the property appraiser or from such other sources
15	as the board or engineer deems reliable, with proof of such
16	mailing to be made by the affidavit of the secretary of the
17	district, or by the engineer, said proof to be filed with the
18	secretary, provided that failure to mail said notice or
19	notices shall not invalidate any of the proceedings hereunder.
20	Notice of the time and place of such hearing shall also be
21	given by two publications a week apart in a newspaper of
22	general circulation in the district, and in like manner in a
23	newspaper of general circulation published in Broward County,
24	provided that the last publication shall be at least 1 week
25	prior to the date of the hearing. Said notice shall describe
26	the streets or other areas to be improved and advise all
27	persons interested that the description of each property to be
28	assessed and the amount to be assessed to each piece or parcel
29	of property may be ascertained at the office of the secretary
30	of the board. Such service by publication shall be verified by

1 the affidavit of the publisher and filed with the secretary of 2 the district. 3 (8) EQUALIZING BOARD TO HEAR COMPLAINTS AND ADJUST 4 ASSESSMENTS; OBJECTIONS; WAIVER OF OBJECTIONS; REBATE OF 5 DIFFERENCE IN COST AND ASSESSMENT; CREATION OF LIEN.--At the time and place named in the notice provided for in subsection б 7 7), the board shall meet as an equalizing board to hear and 8 consider any and all objections as to such special assessments and shall adjust and equalize the said assessments on a basis 9 10 of justice and right; and all objections to any such 11 assessment roll on the grounds it contains items which cannot be properly assessed against the property, or that it is, for 12 any default or defect in the passage or character of the 13 assessment roll or the plans or specifications or estimate, 14 void or voidable in whole or in part, or that it exceeds the 15 power of the board, shall be made in writing in person or by 16 17 attorney, and filed with the secretary of the board at or before the time or adjourned time of such hearing of the 18 assessment roll. Any objections against the making of 19 assessable improvements not so made shall be considered waived 20 and, if any objections shall be made and overruled or shall 21 not be sustained, the confirmation of the assessment shall be 22 the final adjudication of the issue presented unless proper 23 24 steps shall be taken in a court of competent jurisdiction to secure relief within 20 days of such confirmation; and, when 25 so equalized and approved by resolution of the board, such 26 27 assessments shall stand confirmed and remain legal, valid, and binding first liens, upon the property against which such 28 29 assessments are made, until paid. (10) PAYMENT AND COLLECTION OF SPECIAL ASSESSMENT; 4 5 FORECLOSURE; SERVICE OF PROCESS. -б (a) Any assessment may be paid at the office of the 7 secretary of the board within 30 days after the confirmation 8 thereof, without interest. Thereafter, all assessments shall be payable in equal installments, with interest as determined 9 10 by the board, not to exceed the highest rate allowed by law, 11 from the expiration of said 30 days in each of the succeeding number of years not exceeding 20, which the board shall 12 determine by resolution. 1	(e) All assessments shall constitute a lien upon the
2	property so assessed from the date of final confirmation
3	thereof, of the same nature and to the same extent as the lien
4	for general county taxes falling due in the same year or years
5	in which such assessments or installments thereof fall due,
6	and any assessment or installment not paid when due shall be
7	collectible with such interest and with a reasonable
8	attorney's fee and costs, but without penalties, by the
9	district by proceedings in a court of equity to foreclose the

12	proceedings to foreclose shall embrace all installments of

16	foreclosure of any special assessment, service of process
17	against unknown or nonresident defendants may be had by
18	publication, as now provided by law in other chancery suits.
19	The foreclosure proceedings shall be prosecuted to a sale and
20	conveyance of the property involved in said proceedings as now
21	provided by law in suits to foreclose mortgages; or, in the
22	alternative, said proceeding may be instituted and prosecuted
23	under chapter 173, Florida Statutes. Nevertheless, if, prior
24	to any sale of the property under decree of foreclosure in
25	such proceedings, payment be made of the installment or
26	installments which are shown to be due under the provisions of
27	this section, and all costs, including interest and reasonable
28	attorney's fees, such payment shall have the effect of
29	restoring the remaining installments to their original
30	maturities as provided by the resolution and the proceedings
31	shall be dismissed at the cost and expense of the landowner.

1 It shall be the duty of the board to enforce the prompt collection of assessment by the means herein provided, and 2 3 such duty may be enforced by suit by any holder of bonds issued and then outstanding under this act in a court of 4 competent jurisdiction by mandamus or other appropriate 5 б proceedings. Not later than 30 days after the annual 7 installments are due and payable, it shall be the duty of the 8 board to direct the attorney for the district to institute actions within 2 months after such direction to enforce the 9 10 collection of all special assessments for assessable 11 improvements made under this section and remaining due and unpaid at the time of such direction. 1 estate possess or are subject to hereunder, and such real estate of any such county, school district, and political 2 3 subdivision shall be subject to liens for said assessments in all cases where the same property would be subject to such 4 5 liens had it, at the time the lien attached, been owned by a б private owner. 7 (11) ADVERTISEMENT FOR BIDS. -- After the passage of the 8 resolution authorizing the construction or reconstruction of 9 assessable improvements and the final confirmation of the 10 assessment roll, the board shall publish at least once in a 11 newspaper published in Broward County and of general circulation in the district, a notice calling for sealed bids 12 to be received by the district for the construction of the 13 14 work, unless in the initial resolution the board shall have declared its intention to have the work done by district 15 forces without contract. The notice shall refer in general 16 17 terms to the extent and nature of the improvements and may identify the same by the short designation indicated in the 18 19 initial resolution and by reference to the plans and specifications on file. If the initial resolution shall have 20 given two or more alternative descriptions of the assessable 21 improvements as to its material, nature, character, and size, 22 and if the board shall not have theretofore determined upon a 23 24 definite description, the notice shall call for bids upon each 25 of such descriptions. Bids may be requested for the work as a whole or for any part thereof separately and bids may be asked 26 for any one or more of such assessable improvements authorized 27 by the same or different resolutions, but any bid covering 28 29 work upon more than one improvement shall be in such form as to permit a separation of cost as to each improvement. 1 or property as provided in this section, shall be and constitute and have all the qualities and incidents of 2 3 negotiable instruments under the law merchant and the laws of 4 Florida. 5 Section 43. Foreclosure of liens. -- Any lien in favor of the district arising under chapter 298, Florida Statutes, б 7 or under this act may be foreclosed by the district by 8 foreclosure proceedings in the name of the district in the circuit court in like manner as is provided in chapter 173, 9 Florida Statutes, and amendments thereto, and the provisions 10 11 of said chapter shall be applicable to such proceedings with the same force and effect as if said provisions were expressly 12 set forth in this act.
