**Senate Amendment (with title amendment)**

On page 97, between lines 23 and 24,

insert:

Section 80. Effective upon this act becoming a law, subsection (10) of section 627.357, Florida Statutes, is amended to read:

627.357 Medical malpractice self-insurance.--

(10)(a)1. An application to form a self-insurance fund under this section must be filed with the department before October 1, 2002. All self-insurance funds authorized under this paragraph must apply for a certificate of authority to become an authorized insurer by October 1, 2006. Any such fund failing to obtain a certificate of authority as an authorized insurer within 1 year of the date of application therefore shall wind down its affairs and shall not issue coverage after the expiration of the 1-year period.

2. Any self insurance fund established pursuant to

1 this section after April 1, 2002, shall also comply with ss.  
2 624.460-624.489, notwithstanding s. 624.462(2)(a). In the  
3 event of a conflict between the provisions of this section and

5 respect to those sections, provisions solely applicable to  
6 workers' compensation and employers liability insurance shall  
7 not apply to medical malpractice funds.~~A self insurance may~~

16 authorized after April 1, 2002 under s. 627.357, and is  
17 licensed to transact insurance in this state.
