Paragraph (c) of subsection (4) of section 723.037, Florida Statutes, is amended to read: 15 16 723.037 Lot rental increases; reduction in services or 17 utilities; change in rules and regulations; mediation .--18 (4) 19 (c) If the committee disagrees with a park owner's lot 20 rental amount increase based upon comparable mobile home 21 parks, the committee shall disclose to the park owner the 22 name, address, lot rental amount, and any other relevant 23 factors relied upon by the committee, such as facilities, 24 services, and amenities, concerning the comparable mobile home 25 parks. The committee shall provide to the park owner the disclosure, in writing, within 15 days after the meeting with 26 27 the park owner, together with a request for a second meeting. 28 The park owner shall meet with the committee at a mutually 29 convenient time and place within 30 days after receipt by the park owner of the request from the committee to discuss the 30 disclosure provided by the committee. 31
