Section 29. Applicable retroactively, subsection (3) of section 106.021, Florida Statutes, is amended to read:

106.021 Campaign treasurers; deputies; primary and secondary depositories.--

(3) Except for independent expenditures, no contribution or expenditure, including contributions or expenditures of a candidate or of the candidate's family, shall be directly or indirectly made or received in furtherance of the candidacy of any person for nomination or election to political office in the state or on behalf of any political committee except through the duly appointed campaign treasurer of the candidate or political committee; however, a candidate or any other individual may be reimbursed for expenses incurred for travel, food and beverage, office supplies, and mementos expressing gratitude to campaign

1 supporters by a check drawn upon the campaign account and
2 reported pursuant to s. 106.07(4). In addition ~~However~~,
3 expenditures may be made directly by any political committee
4 or political party regulated by chapter 103 for obtaining
5 time, space, or services in or by any communications medium
6 for the purpose of jointly endorsing three or more candidates,
7 and any such expenditure shall not be considered a
8 contribution or expenditure to or on behalf of any such
9 candidates for the purposes of this chapter.

10 Section 30. Applicable retroactively, paragraph (a) of
11 subsection (4) of section 106.07, Florida Statutes, is amended
12 to read:

13 106.07 Reports; certification and filing.--

14 (4)(a) Each report required by this section shall
15 contain:

16 1. The full name, address, and occupation, if any of
17 each person who has made one or more contributions to or for
18 such committee or candidate within the reporting period,
19 together with the amount and date of such contributions. For
20 corporations, the report must provide as clear a description
21 as practicable of the principal type of business conducted by
22 the corporation. However, if the contribution is \$100 or less
23 or is from a relative, as defined in s. 112.312, provided that
24 the relationship is reported, the occupation of the
25 contributor or the principal type of business need not be
26 listed.

27 2. The name and address of each political committee
28 from which the reporting committee or the candidate received,
29 or to which the reporting committee or candidate made, any
30 transfer of funds, together with the amounts and dates of all
31 transfers.

1 3. Each loan for campaign purposes to or from any
2 person or political committee within the reporting period,
3 together with the full names, addresses, and occupations, and
4 principal places of business, if any, of the lender and
5 endorsers, if any, and the date and amount of such loans.

6 4. A statement of each contribution, rebate, refund,
7 or other receipt not otherwise listed under subparagraphs 1.
8 through 3.

9 5. The total sums of all loans, in-kind contributions,
10 and other receipts by or for such committee or candidate
11 during the reporting period. The reporting forms shall be
12 designed to elicit separate totals for in-kind contributions,
13 loans, and other receipts.

14 6. The full name and address of each person to whom
15 expenditures have been made by or on behalf of the committee
16 or candidate within the reporting period; the amount, date,
17 and purpose of each such expenditure; and the name and address
18 of, and office sought by, each candidate on whose behalf such
19 expenditure was made. However, expenditures made from the
20 petty cash fund provided by s. 106.12 need not be reported
21 individually.

22 7. The full name and address of each person to whom an
23 expenditure for personal services, salary, or reimbursement
24 for authorized expenses as provided in s. 106.021(3) has been
25 made and which is not otherwise reported, including the
26 amount, date, and purpose of such expenditure. However,
27 expenditures made from the petty cash fund provided for in s.
28 106.12 need not be reported individually.

29 8. The total amount withdrawn and the total amount
30 spent for petty cash purposes pursuant to this chapter during
31 the reporting period.

- 1 9. The total sum of expenditures made by such
- 2 committee or candidate during the reporting period.
- 3 10. The amount and nature of debts and obligations
- 4 owed by or to the committee or candidate, which relate to the
- 5 conduct of any political campaign.
- 6 11. A copy of each credit card statement which shall
- 7 be included in the next report following receipt thereof by
- 8 the candidate or political committee. Receipts for each credit
- 9 card purchase shall be retained by the treasurer with the
- 10 records for the campaign account.
- 11 12. The amount and nature of any separate
- 12 interest-bearing accounts or certificates of deposit and
- 13 identification of the financial institution in which such
- 14 accounts or certificates of deposit are located.
