On page 15, between lines 25 and 26,

insert:

Section 11. Section 893.065, Florida Statutes, is created to read:

Section 893.065 Voluntary program for counterfeit-resistant prescription blanks.--The Department of Legal Affairs, may, by rule, after consultation with the prescription monitoring program advisory council established under this act, develop a voluntary program for counterfeit-resistant prescription blanks to be used by practitioners who prescribe controlled substances or any drug of abuse under the electronic prescription-monitoring system which has been designated by the Attorney General. The Department of Legal Affairs may develop, by rule, a counterfeit-resistant prescription blank for voluntary use by practitioners who prescribe controlled substances or any drug of abuse under the electronic prescription monitoring system.

1 The Department of Legal Affairs may, by rule, require the  
2 blanks to be printed on distinctive paper, serially numbered,  
3 and to bear the preprinted name, address, and category of  
4 professional licensure of the practitioner to whom they are  
5 issued and that practitioner's federal registry number for  
6 controlled substances. The prescription blanks may be issued  
7 by the Department of Legal Affairs in serially numbered groups  
8 to prescribing practitioners. If such blanks are issued by the  
9 Department of Legal Affairs to implement a voluntary program  
10 for counterfeit-resistant prescription blanks, a copy must be  
11 available for inspection by the Department of Legal Affairs,  
12 and all costs of preparing, issuing, and tracking prescription  
13 blanks may be covered by the Department of Legal Affairs.
