or electronic devices, in any proceeding pending in any of the state or federal courts of the state, including all discovery proceedings conducted in connection therewith, and all proceedings required by statute to be reported by a certified or official court reporter or any administrative hearing or official proceeding. Court reporting does not include the act of electronic recording or the transcription of any electronic recording.

- (3) REGISTRATION REQUIRED.--Notwithstanding s. 25.383, effective January 1, 2003, all court reporters must be registered with the Florida Court Reporters Association.
- (4) REGISTRY OF COURT REPORTERS CREATED. -- The Florida Court Reporters Association is authorized to create and maintain a registry of all court reporters who transcribe any proceeding held in the state. The association shall determine an annual fee to be collected by the association for the purpose of maintaining a statewide registry of all Florida court reporters. The registration fee must cover the normal and customary costs associated with the creation and maintenance of the registry. Upon registration, the association shall issue each court reporter a registration number that must appear on all transcripts taken or used in any court proceeding, administrative hearing, or official meeting of any public body. The Florida Court Reporters Association shall make available to the general public upon request the current business location information for any court reporter registered within the state.
- (5) REGISTRATION NUMBER REQUIRED ON ALL

 TRANSCRIPTS.--Effective June 1, 2003, all transcripts taken or transcribed by any court reporter in any proceeding must contain the registration number of the court reporter who
