Lee Moffitt Cancer Center and Research 3 Institute, established under s. 240.512, by warrant drawn by 4 5 the Comptroller upon the State Treasury. These funds are hereby appropriated monthly out of the Cigarette Tax 6 7 Collection Trust Fund, to be used for the purpose of 8 constructing, furnishing, and equipping a cancer research facility at the University of South Florida adjacent to the H. 9 Lee Moffitt Cancer Center and Research Institute. Directors of the H. Lee Moffitt Cancer Center and Research Institute pursuant to s. 210.20 shall be used to secure financing to pay costs related to constructing, furnishing, and equipping the cancer research facility. Such financing may include the issuance of tax exempt bonds by a local authority, municipality, or county pursuant to parts II and III of chapter 159. Such bonds shall not constitute state bonds for purposes of s. 11, Art. VII of the State Constitution, but shall constitute bonds of a "local agency," as defined in s. 159.27(4). The cigarette tax dollars pledged to this facility pursuant to s. 210.20 may shall be replaced annually by the Legislature from tobacco litigation settlement proceeds. Section 3. This act shall take effect upon becoming a law. HOUSE SUMMARY Increases that portion of the revenues from the cigarette tax to be paid monthly to the Board of Directors of the H. Lee Moffitt Cancer Center and Research Institute to finance a cancer research facility at the University of South Florida. Provides for the use of the transferred moneys. Authorizes, rather than requires, replacement of such moneys by tobacco settlement proceeds.
