**Senate Amendment (with title amendment)**

On page 2, between lines 2 and 3,

insert:

Section 4. Subsection (3) of section 338.165, Florida Statutes, is amended to read:

338.165 Continuation of tolls.--

(3) Notwithstanding any other law to the contrary, pursuant to s. 11, Art. VII of the State Constitution, and subject to the requirements of subsection (2), the Department of Transportation may request the Division of Bond Finance to issue bonds secured by toll revenues collected on the Alligator Alley, Sunshine Skyway Bridge, Beeline East Expressway, and Pinellas Bayway to fund transportation projects located within the county or counties in which the facility is located and contained in the 1993-1994 Adopted Work Program or in any subsequent adopted work program of the department.

1 Section 5. Paragraph (c) of subsection (4) of section  
2 339.12, Florida Statutes, is amended to read:

3 339.12 Aid and contributions by governmental entities  
4 for department projects; federal aid.--

6 (c) The department may enter into agreements under  
7 this subsection for a project or project phase not included in  
8 the adopted work program. As used in this paragraph, the term  
9 "project phase" means acquisition of rights-of-way,  
10 construction, construction inspection, and related support  
11 phases. The project or project phase must be a high priority  
12 of the governmental entity. Reimbursement for a project or  
13 project phase must be made from funds appropriated by the  
14 Legislature pursuant to s. 339.135(5). All other provisions of  
15 this subsection apply to agreements entered into under this  
16 paragraph. The total amount of project agreements for projects  
17 or project phases not included in the adopted work program may  
18 not at any time exceed ~~\$150~~\$100 million.
