A reviser's bill to be entitled
 An act relating to the official Florida Statutes; amending
 ss. 11.2421, 11.2422, 11.2424, and 11.2425, F.S.; adopting
 the Florida Statutes 2003 and designating the portions
 thereof that are to constitute the official law of the
 state; providing that the Florida Statutes 2003 shall be
 effective immediately upon publication; providing that
 general laws enacted during the April 29-May 13, 2002,
 special session and prior thereto and not included in the
 Florida Statutes 2003 are repealed; providing that general
 laws enacted during the 2003 regular session are not
 repealed by this adoption act.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 11.2421, Florida Statutes, is amended
 to read:

11.2421 Florida Statutes 2003 ~~1999~~ adopted.--The
 accompanying revision, consolidation, and compilation of the
 public statutes of 2002 ~~1997~~ of a general and permanent nature,
 excepting tables, rules, indexes, and other related matter
 contained therein, prepared by the Office of Legislative
 Services under the provisions of s. 11.242, together with
 corrections, changes, and amendments to and repeals of
 provisions of Florida Statutes 2002 ~~1997~~ enacted in additional
 reviser's bill or bills by the 2003 ~~1999~~ Legislature, is adopted
 and enacted as the official statute law of the state under the
 title of "Florida Statutes 2003 ~~1999~~" and shall take effect
 immediately upon publication. Said statutes may be cited as

32 Section 2. Section 11.2422, Florida Statutes, is amended
 33 to read:

34 11.2422 Statutes repealed.--Every statute of a general and
 35 permanent nature enacted by the State or by the Territory of
 36 Florida at or prior to the April 29-May 13, 2002, special
 37 ~~regular~~ ~~1997~~ legislative session, and every part of such
 38 statute, not included in Florida Statutes 2003 ~~1999~~, as adopted
 39 by s. 11.2421, as amended, or recognized and continued in force
 40 by reference therein or in ss. 11.2423 and 11.2424, as amended,
 41 is repealed.

42 Section 3. Section 11.2424, Florida Statutes, is amended
 43 to read:

44 11.2424 Laws not repealed.--Laws enacted at the 2003
 45 ~~November 1997 special session, the 1998 regular session, and the~~
 46 ~~1999~~ regular session are not repealed by the adoption and
 47 enactment of the Florida Statutes 2003 ~~1999~~ by s. 11.2421, as
 48 amended, but shall have full effect as if enacted after its said
 49 adoption and enactment.

50 Section 4. Section 11.2425, Florida Statutes, is amended
 51 to read:

52 11.2425 Rights reserved under repealed statutes.--The
 53 repeal of any statute by the adoption and enactment of Florida
 54 Statutes 2003 ~~1999~~, by s. 11.2421, as amended, shall not affect
 55 any right accrued before such repeal or any civil remedy where a
 56 suit is pending.

57 Section 5. This act shall take effect on the 60th day
 58 after adjournment sine die of the session of the Legislature in
 59 which enacted.
