Twenty percent shall be distributed to programs that provide relief for poverty, hunger, and homelessness as follows: five percent to the Community Partnership for Homeless, Inc., Miami, Florida; five percent to the I.M. Sulzbacher Center for the Homeless, Inc., Jacksonville, Florida; five percent to the Anthony House for the Homeless, Zellwood, Florida; and five percent to the Homeless Emergency Project, Inc., Clearwater, Florida.
