1 First to fund programs, projects, seminars, events, and family
 2 resources that promote principles for building marriages,

 4 Family First shall retain all revenues from the sale of the
 5 plate until all startup costs for developing and establishing
 6 the plate have been recovered. Up to 5 percent of the funds
 7 received by Family First may be expended for administrative
 8 costs directly associated with the operations of Family First.
 9 Up to 20 percent of the funds received by Family First may be
 10 expended for promotion and marketing of the license plate.
 11 Family First may expend all remaining funds for programs.
