Between lines 2995 and 2996, insert:

(5)(a) As used in this subsection, the term:

1. "Pretrial release service" means any government-funded program whose functions include making recommendations to any court regarding the pretrial release of any defendant from custody.

2. "Annual report" means a report prepared by a pretrial release service that accurately and objectively reports the performance of such service with the use of taxpayer monies.

(b) The pretrial release service in any county of the state shall maintain data compiled on a monthly basis regarding the cases and defendants who are processed for release by such service. The data to be maintained shall display accurate,

27 objective information for each defendant, including, but not
28 limited to:

29 1. The charges against each defendant.

30 2. The nature of any prior arrest against each defendant.

31 3. The court appearances required for each defendant.

32 4. Each court appearance at which the defendant failed to
33 appear.

34 5. Each capias issued, as well as each time a capias was
35 not issued when the defendant failed to appear.

36 6. The recommendation of the pretrial release service
37 relative to each defendant.

38 (c) By December 1 of each year, the pretrial release
39 service shall submit an annual report to the chair of the
40 governing authority of the county, the Governor, the Speaker of
41 the House of Representatives, and the President of the Senate.

42 (d) The annual report shall be submitted in a format
43 approved by the Executive Office of the Governor, in
44 consultation with the Office of the State Courts Administrator.

45 The annual report shall include, but not be limited to:

46 1. The operating budget of the pretrial release service.

47 2. The number of personnel employed by or contracted with
48 the pretrial release service.

49 3. The number and disposition of all cases reviewed by the
50 pretrial release service.

51 4. The number of cases, categorized as either felony or
52 misdemeanor, where the defendant was released with a financial
53 condition.

54 5. The number of cases, categorized as either felony or
55 misdemeanor, where the defendant was released without financial
56 conditions.

57 (e) No additional public funds shall be expended for the
