The Commissioner of Agriculture shall appoint the remaining members. The council shall make periodic reports to 8 9 the Department of Agriculture and Consumer Services concerning findings and recommendations in the area of food safety and 10 food security. 11 12 (2) The council shall consider the development of appropriate advice or recommendations on food safety or food 13 14 security issues.
