A memorial to the Congress of the United

States, urging Congress to include in its
economic-stimulus legislation tax incentives
for building owners who upgrade their
firesafety systems consistent with the
firesafety provisions of the National Fire
Protection Association's Life Safety Code in
existing high-rise buildings.

WHEREAS, providing a firesafe environment for our nation's citizens and visitors is an obligation shared by federal, state, and local governments, and

WHEREAS, to fulfill this role, local governments adopt and enforce model building and fire codes promulgated by code-development authorities, and

WHEREAS, following two major high-rise fires, MGM Grand Hotel in Las Vegas (85 deaths) and the Dupont Plaza Hotel in San Juan (97 deaths), national code-development authorities focused on high-rise buildings because of the potential for major loss of life and untenable fire-suppression conditions, and

WHEREAS, independent studies have found that fire departments cannot respond fast enough to prevent flashover on upper floors of a high-rise building, and

WHEREAS, the National Fire Protection Association's Life Safety Code is nationally accepted and, through adoption by state or local government, is used in all 50 states as a firesafety standard, and

WHEREAS, the Life Safety Code has contained special firesafety requirements for high-rise buildings since its 1991

edition, and Florida has adopted the current edition of the Life Safety Code, and

WHEREAS, protecting Florida's economic foundation and infrastructure is a paramount mission of the Florida

Legislature, and the negative economic impact of a tragic fire in high-rise residential structures can be documented by looking at declining tourism following the MGM Grand Hotel fire in Las Vegas and the Dupont Plaza Hotel in San Juan, and

WHEREAS, enforcing high-rise firesafety standards for existing buildings causes hardships for building owners, particularly condominium owners living on fixed incomes, and

WHEREAS, providing tax incentives for building owners that upgrade firesafety systems in existing high-rise buildings is consistent with President Bush's economic stimulus objectives, NOW, THEREFORE,

Be It Resolved by the Legislature of the State of Florida:

That the Congress of the United States is requested to include in its economic-stimulus legislation tax incentives for building owners who upgrade their firesafety systems consistent with the firesafety provisions of the National Fire Protection Association's Life Safety Code in existing high-rise buildings and that the effective dates for this incentive be January 1, 2002, through December 31, 2014.

BE IT FURTHER RESOLVED that copies of this memorial be dispatched to the President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives, and to each member of the Florida delegation to the United States Congress.
